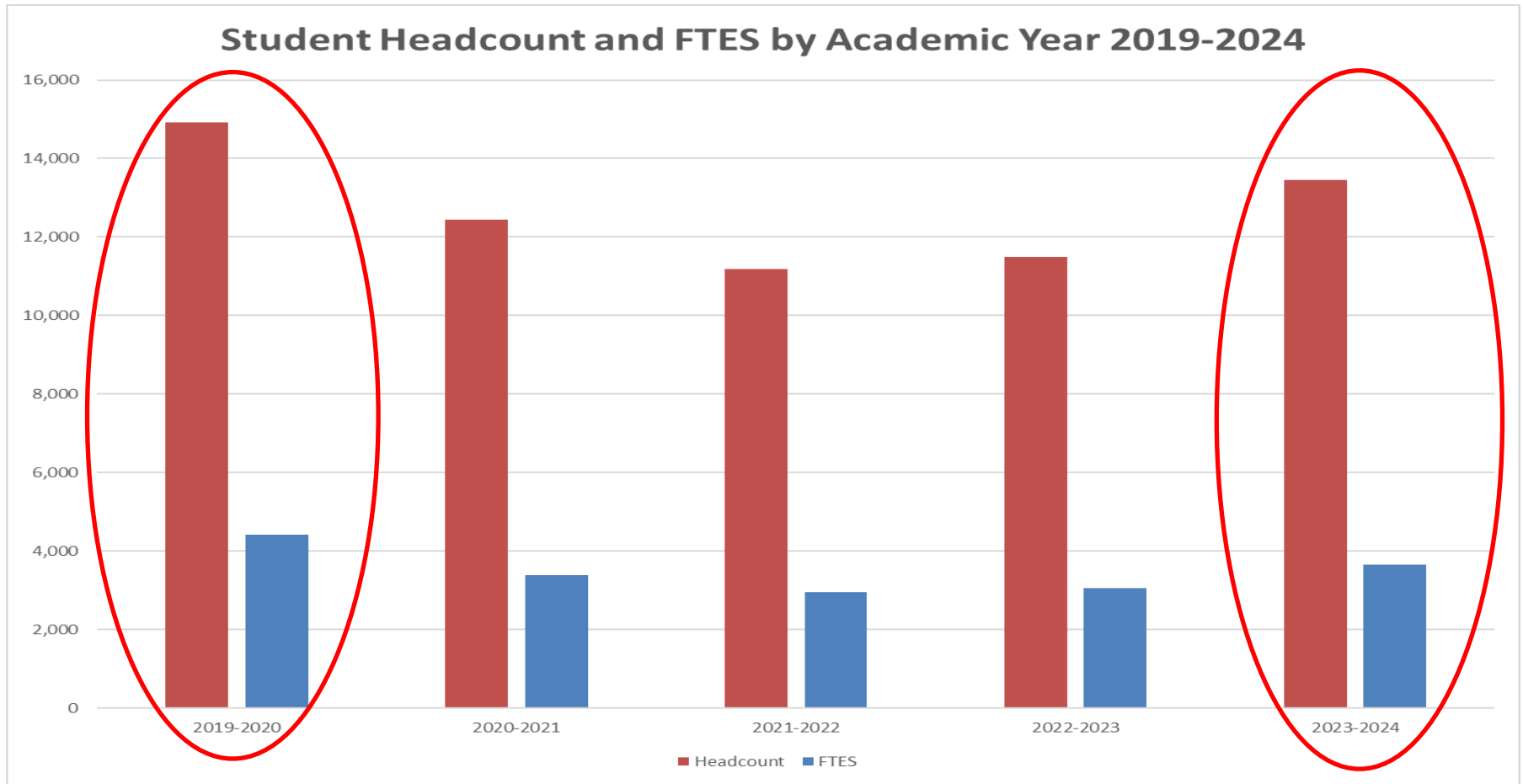

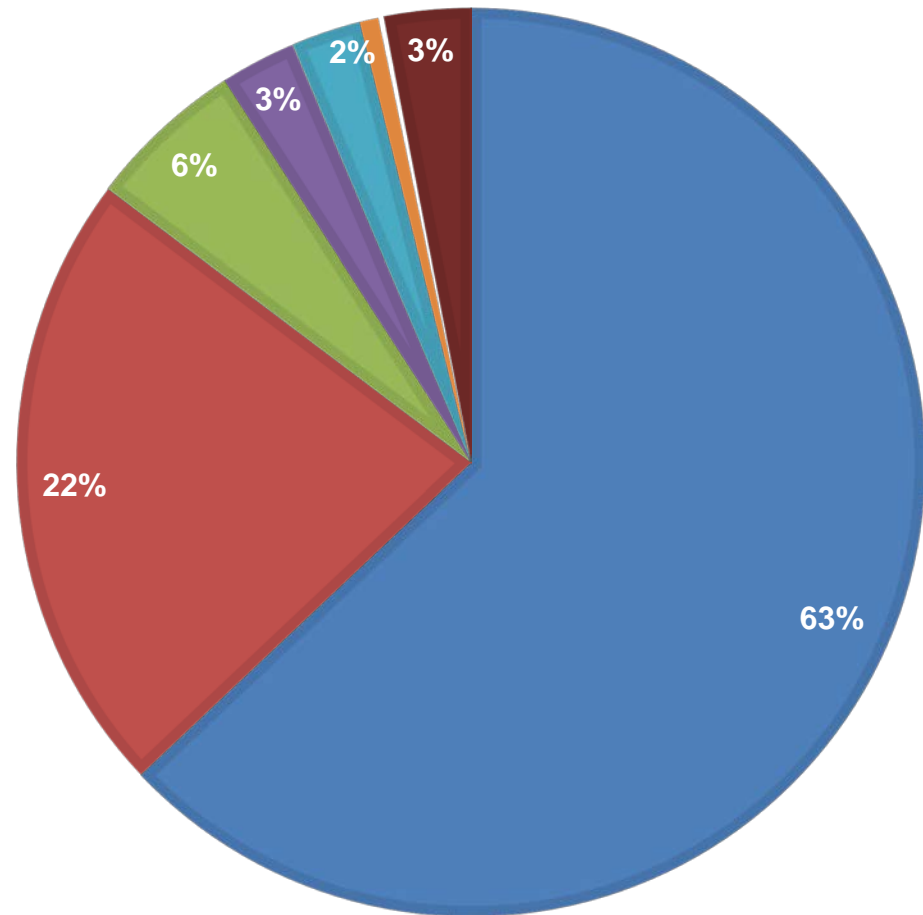

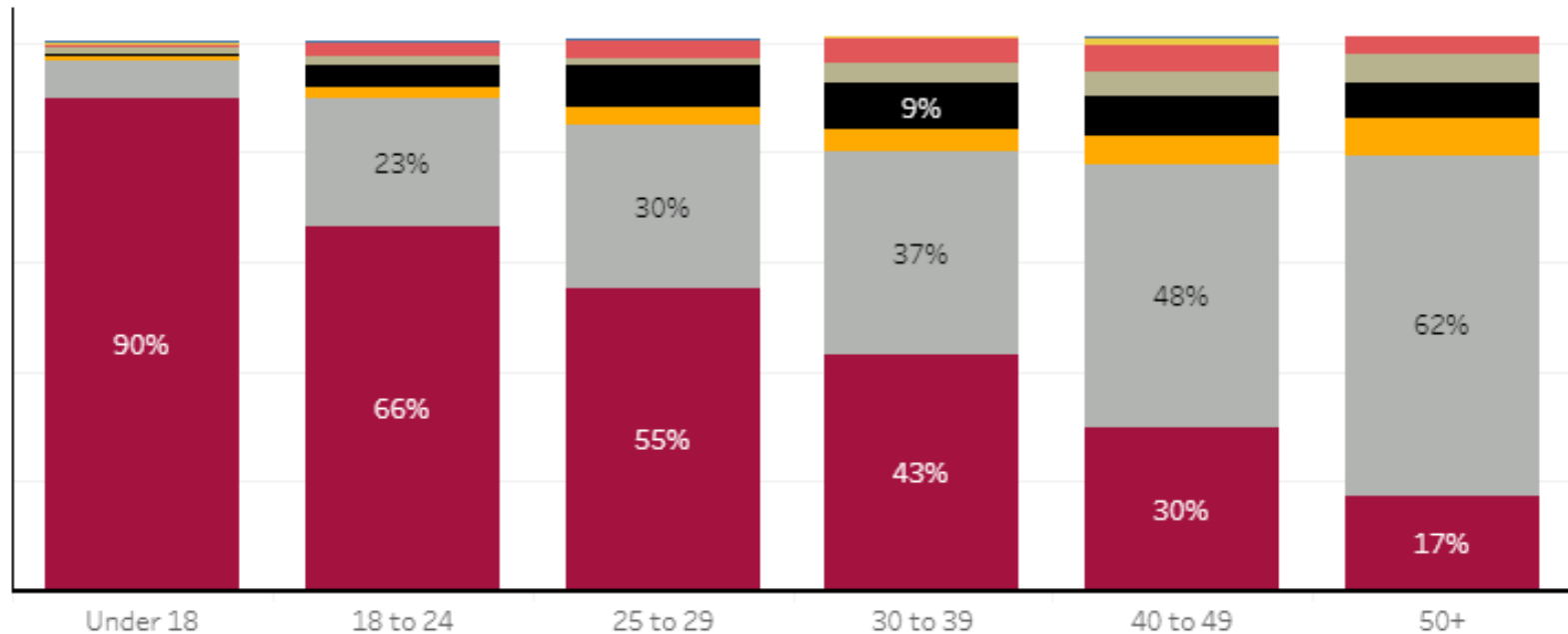

Age by Ethnicity

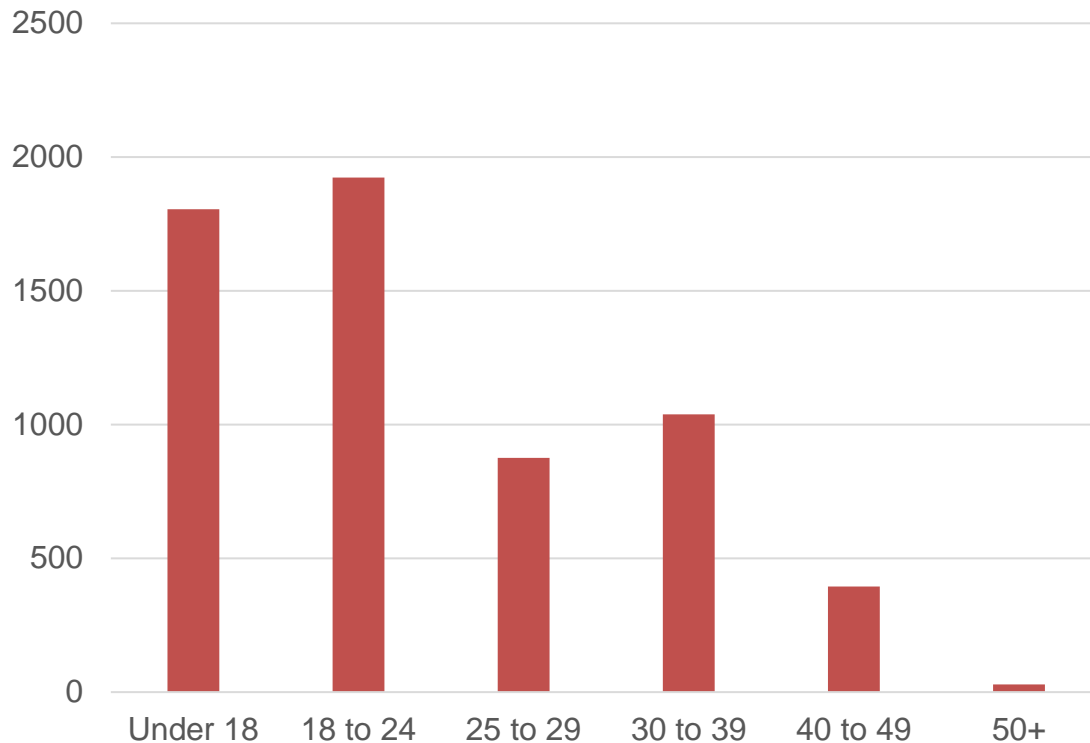

Age Group



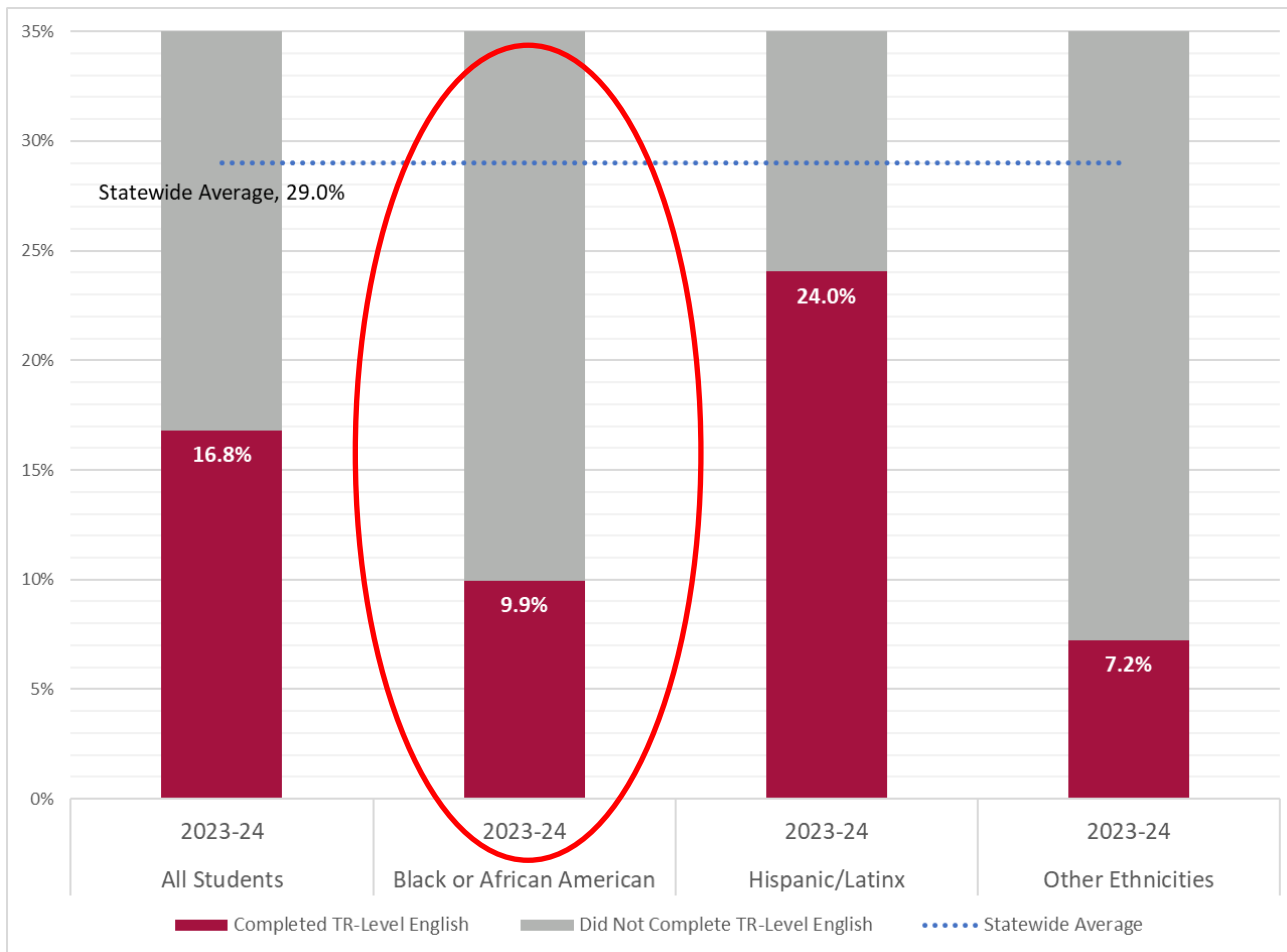

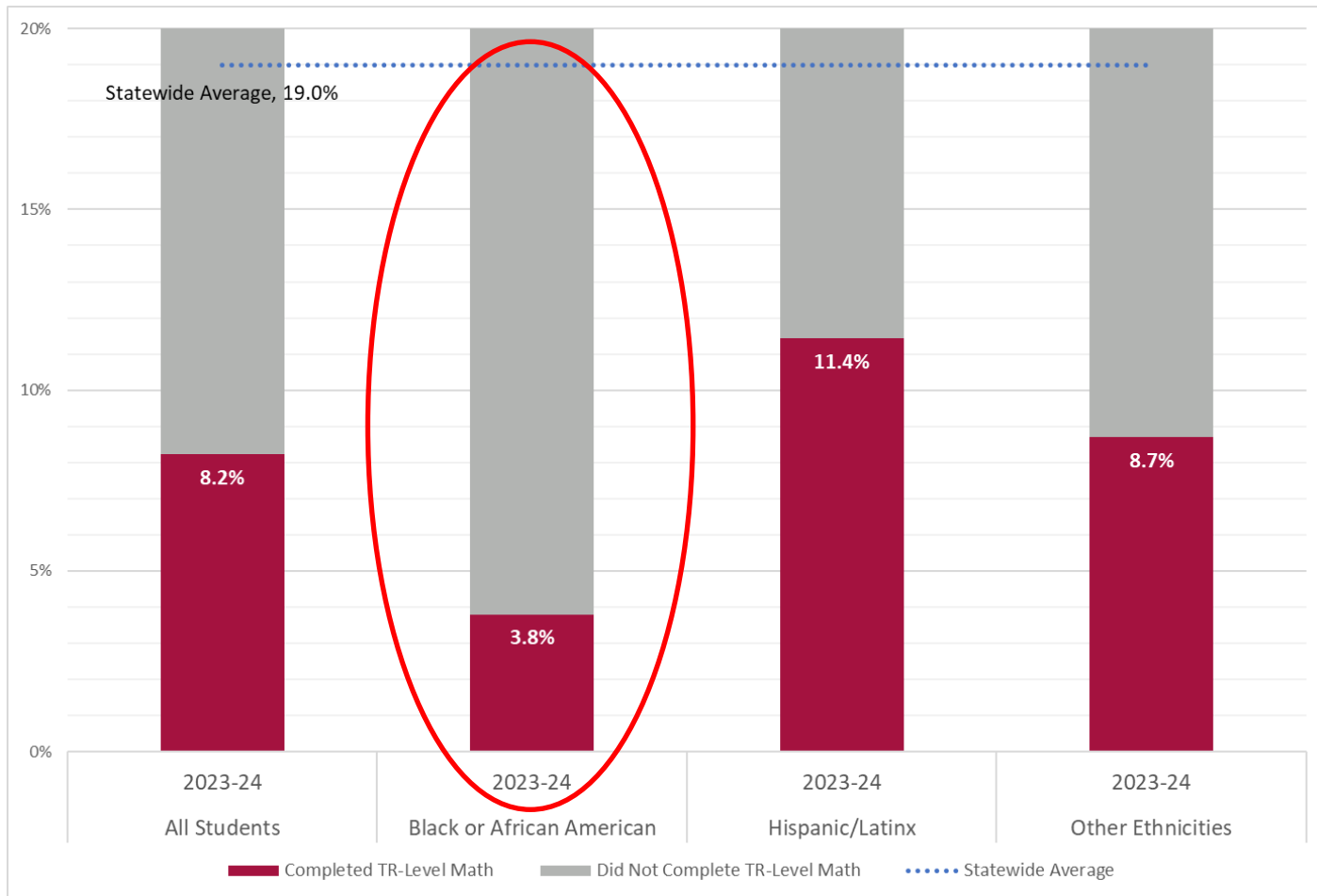

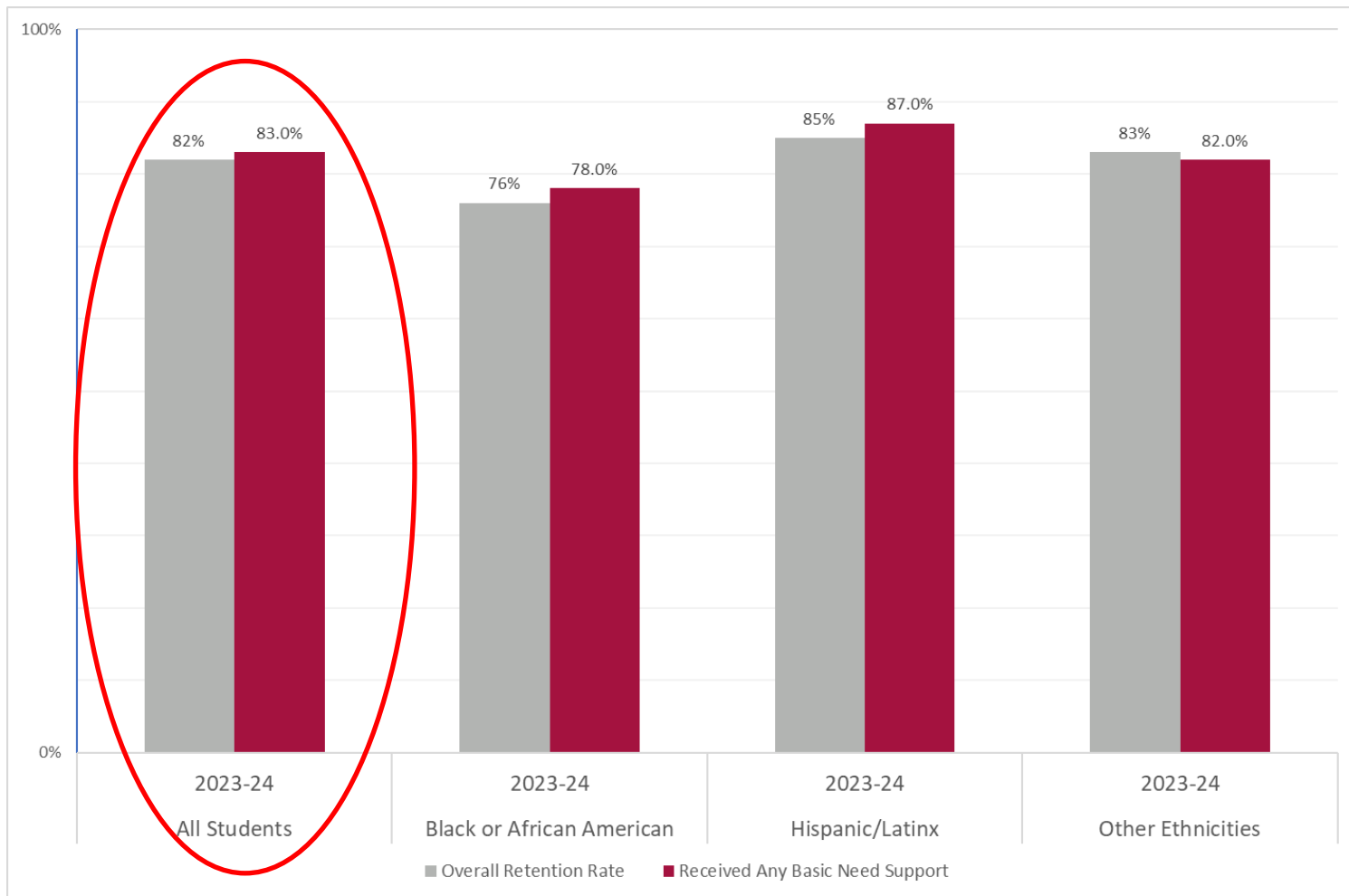
Completion of Transfer-Level English



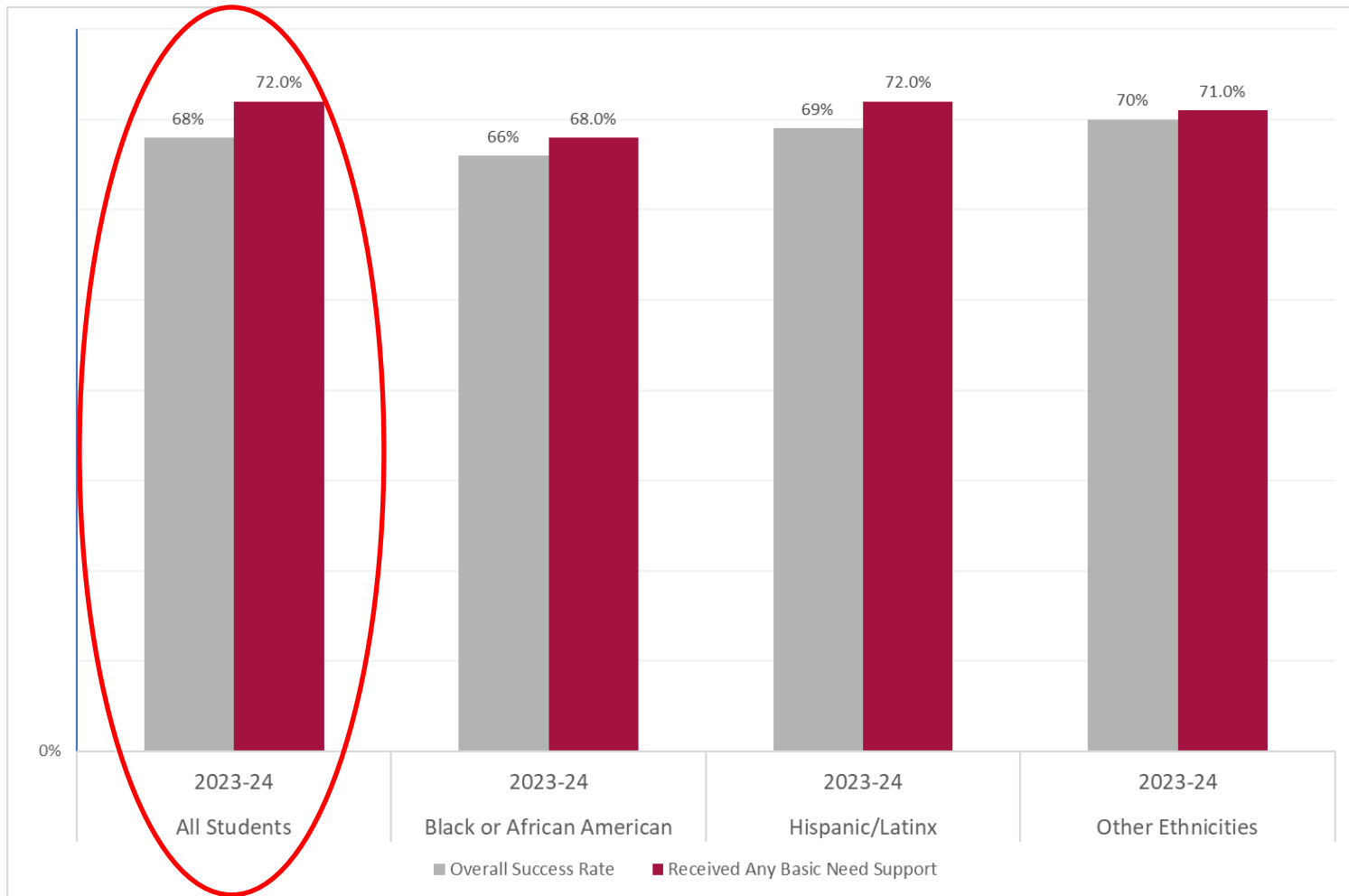
Completion of Transfer-Level Math



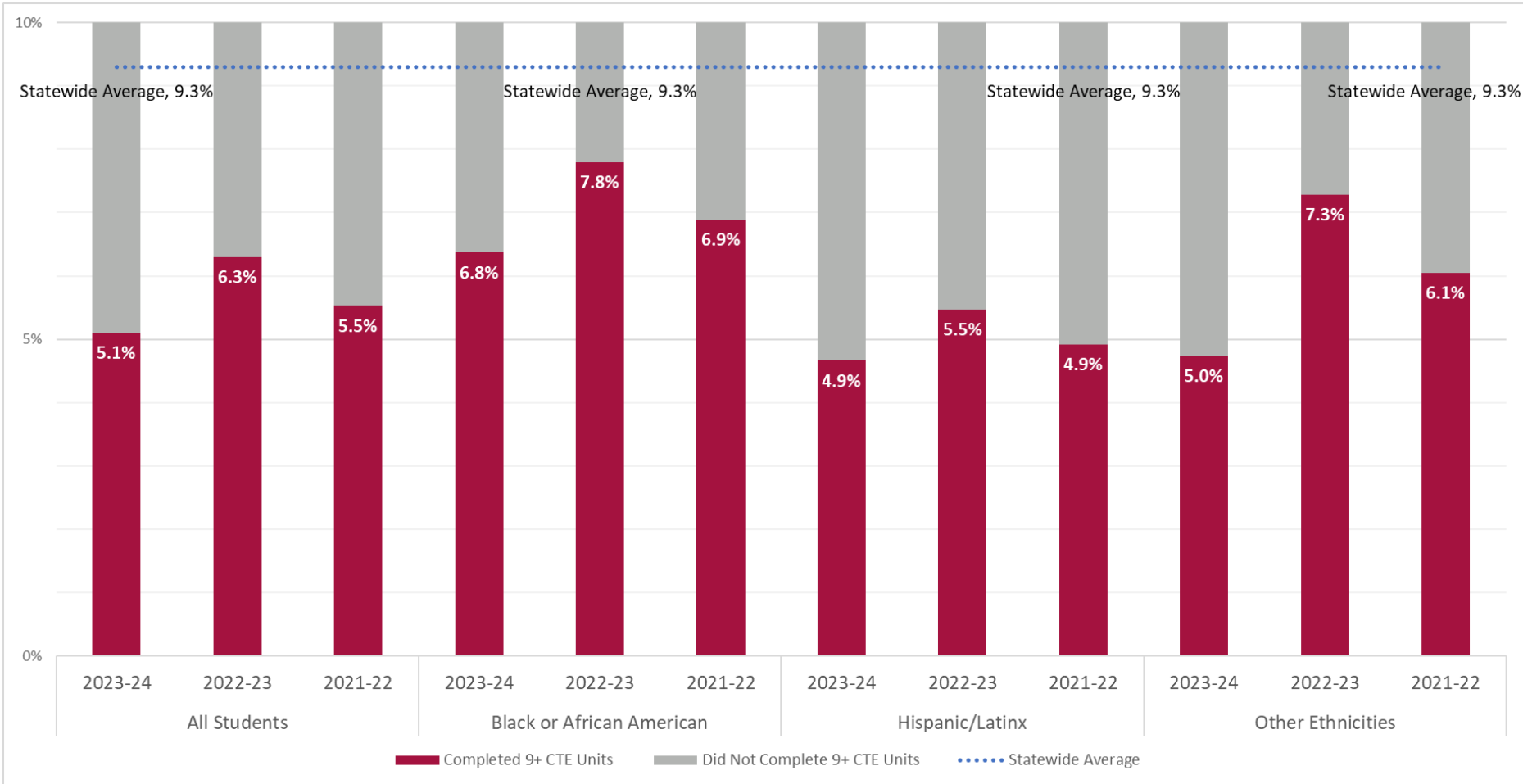
Basic Needs and Student Retention



Basic Needs and Student Success

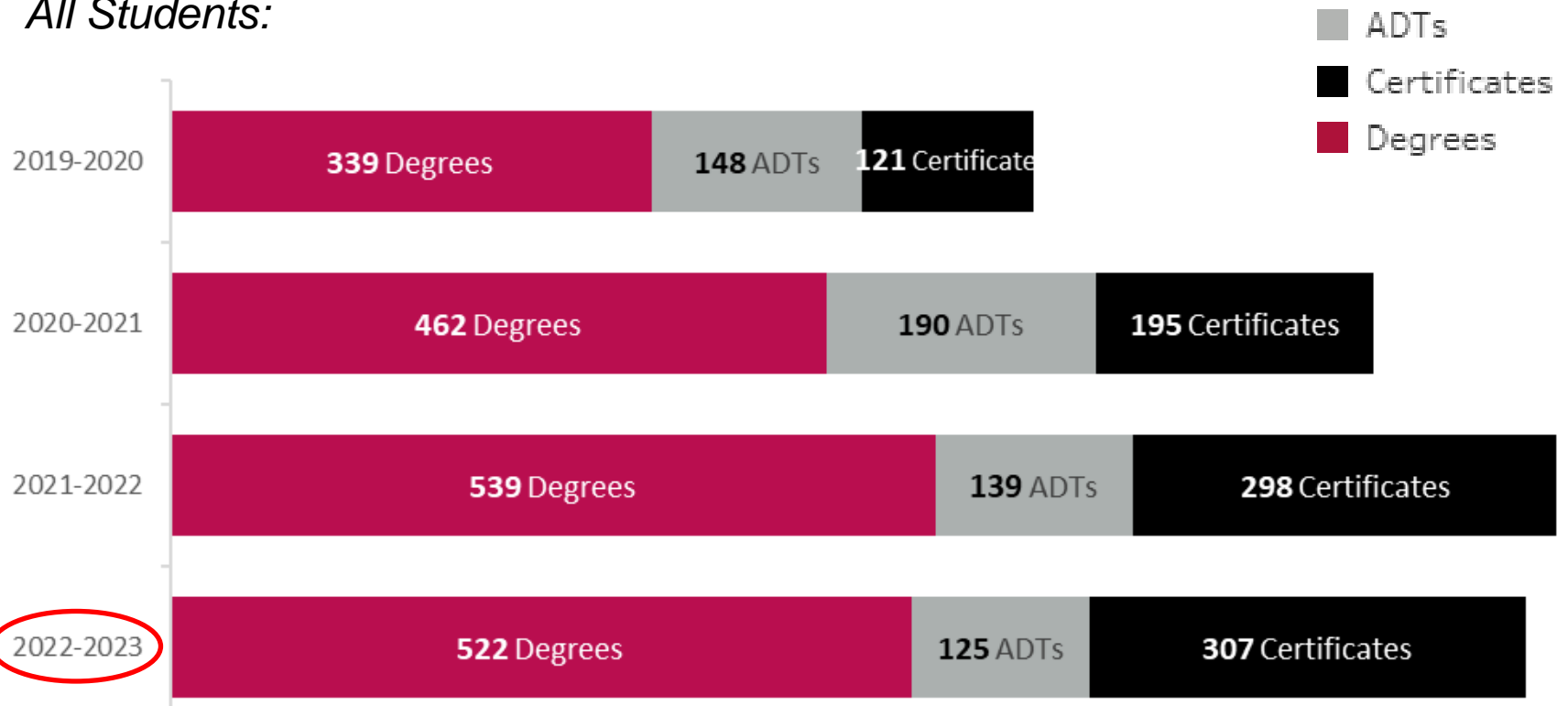


Completion of 9+ CTE Units

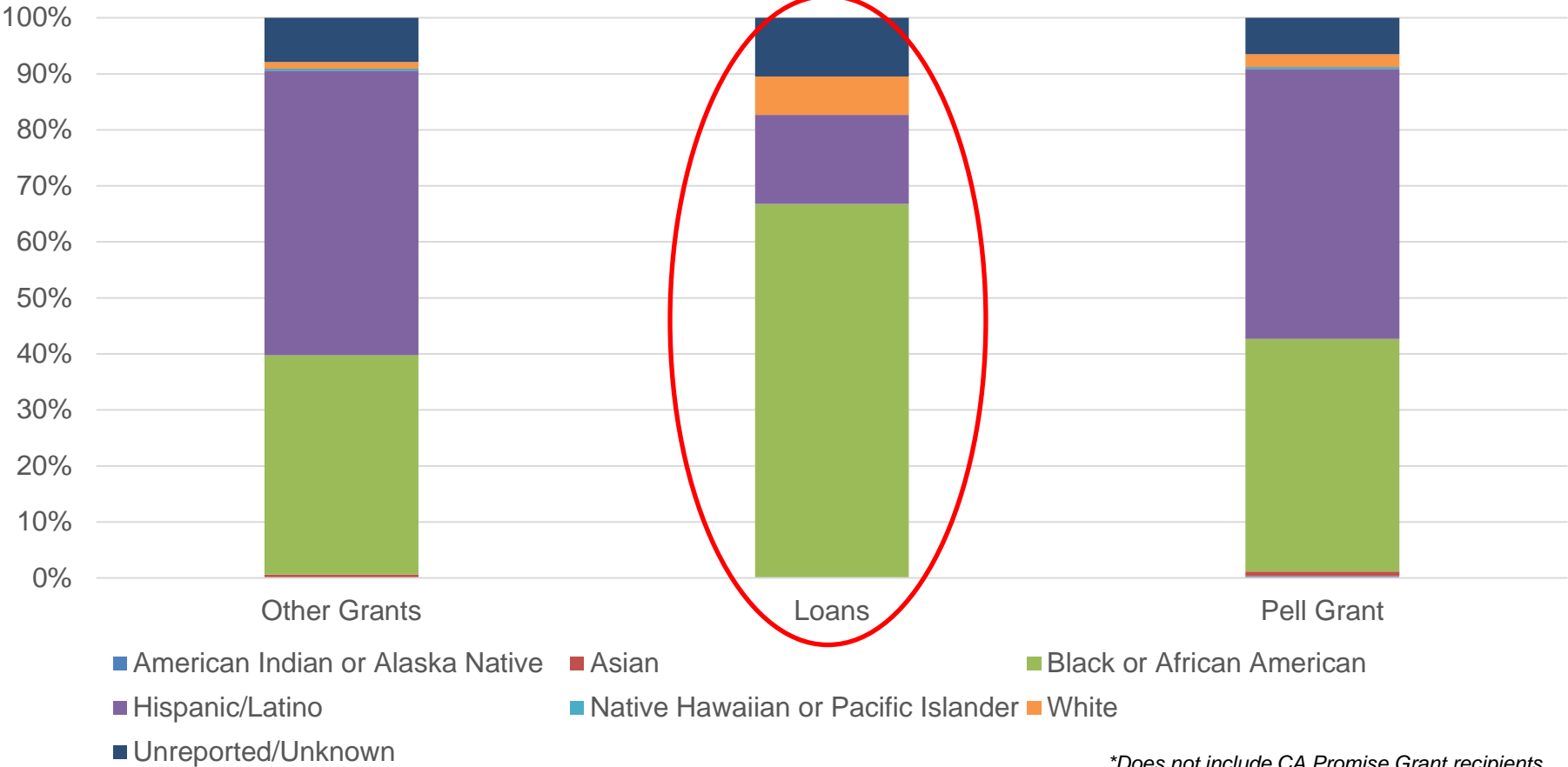

Current Construction Projects

- Demolition of D Row
 - Completion – September 2024
- Grand Opening Ceremony
 - Instructional Buildings 1 and 2
 - Tuesday, October 15 at 3:30 p.m.
- Administration Building Renovation
 - Renovation to make room for Administrative Services and Human Resources
 - Completion estimated for December 2024

Future Construction Projects

Physical Education Complex: This \$52 million project includes the demolition of the current gymnasium, men's shower/locker, classroom V, pool service, pool, and women's shower/locker buildings; and the construction of a new gymnasium, men's and women's locker room, faculty office space, and physical education support space.



Future Construction Projects

Visual Performing Arts Complex: This \$13.4 million project includes the replacement of three of four wings of the Music Y Building, which have not been touched since their construction in 1958. The new Visual and Performing Arts Building will bring modern, seismically safe, efficient spaces to the Music and Dance programs. A new blackbox theatre will be configured for flexibility to meet the needs of both programs. The building will include acoustically isolated individual music practice rooms.



Future Construction Projects

On June 26, 2022, California lawmakers moved to include a student housing grant totaling \$80,389,000 in the 2022-2023 State Budget for the Compton Community College District (CCCD) to build its proposed **250-bed student housing facility on the Compton College campus.**

Circulation and Parking

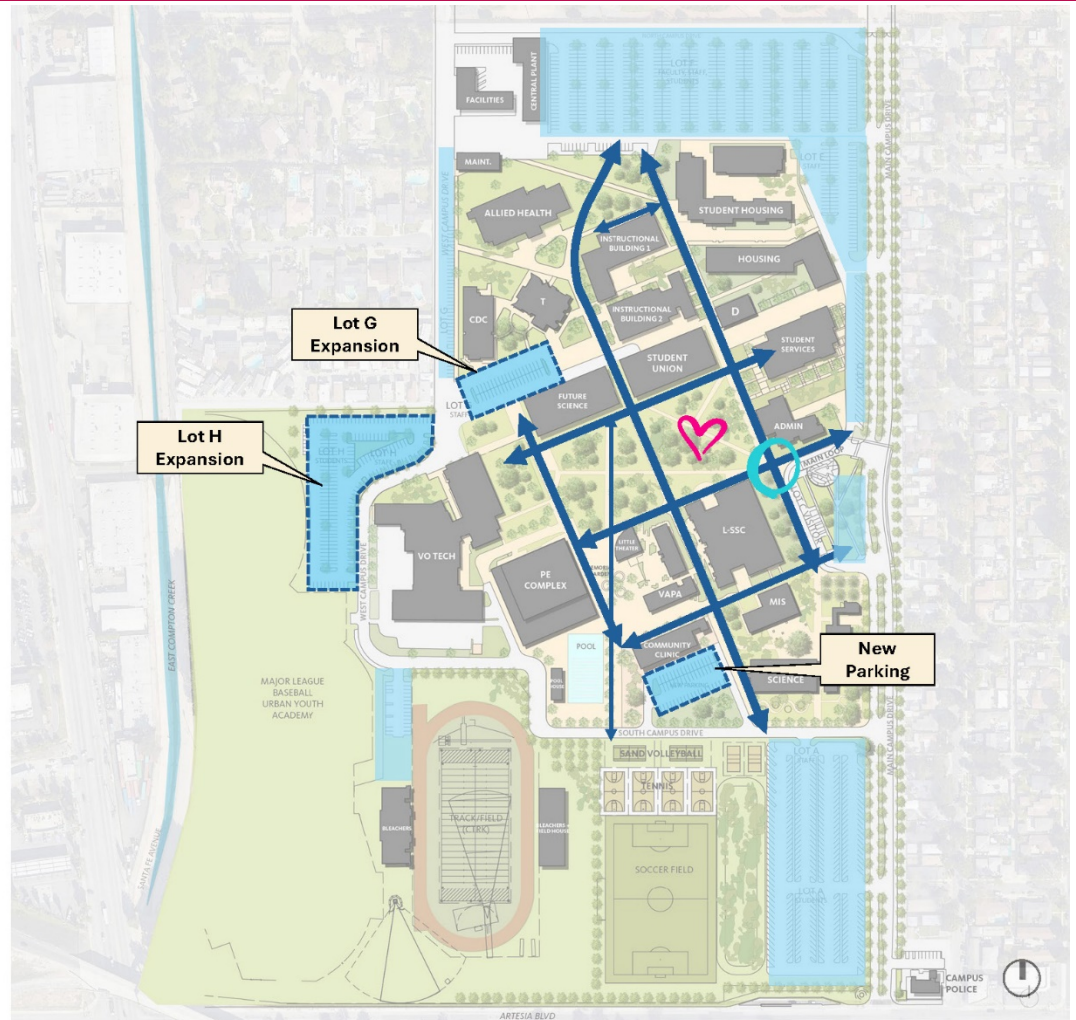
Circulation and parking patterns are illustrated in the adjacent plan.

Pedestrian paths are clarified to establish clear wayfinding across the campus, with a main entry located between the Admin and Student Services Building.

The heart of the campus remains in the central quad, surrounded by key student services.

Parking expansions are proposed in 3 locations and will improve the distribution of lots around the campus.

2024 Measure CC Facilities Bond

On July 16, 2024, the Compton CCD Board of Trustees approved a resolution authorizing a \$200 million facilities bond measure, in compliance with Proposition 39, to be placed on the November 5, 2024, ballot.

“COMPTON COLLEGE REPAIR, JOB TRAINING/ EDUCATION IMPROVEMENT MEASURE. To repair, construct, acquire educational facilities, sites, equipment; support career education for students/ workers/ veterans, firefighter/ police training; remove asbestos; upgrade science labs, computer technology, campus/ earthquake safety, handicap accessibility; provide community healthcare services/ training; shall Compton Community College District authorize \$200,000,000 in bonds at legal rates, levying \$20 per \$100,000 of assessed valuation, generating \$16,150,000 annually while bonds are outstanding be adopted, requiring audits, oversight, all funds used locally?”

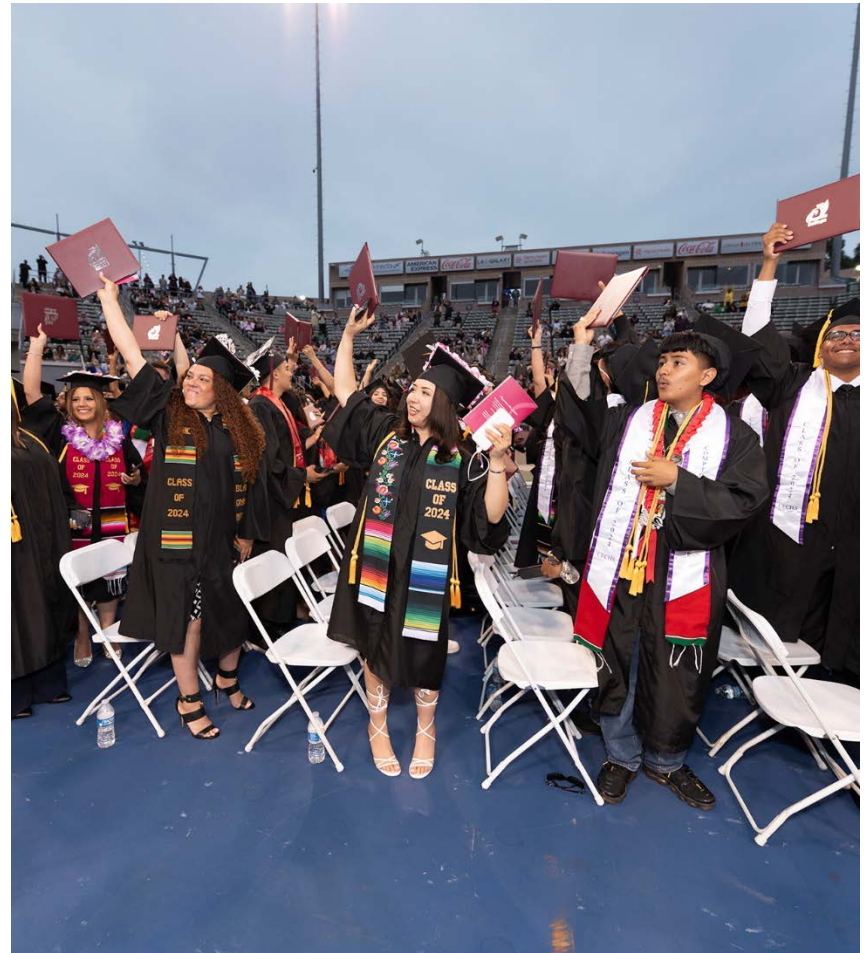

Caring Campus Behavioral Commitments

- **Ten Foot Rule:** Whenever a student is within 10' and seems to need assistance take the initiative to approach them. Say hello, smile, and use a positive tone.
- **Nametags:** Wear name badges or lanyards with the college name on them so that students will know who to approach with questions.
- **Cross-Department Awareness:** Learn about other departments so you know where to send students. Maintain accurate and up-to-date detailed directories.
- **Warm Referrals:** Call ahead or walk students to the office they need to get to. Follow up to ensure the student got there.
- **First Week Greetings:** During the first week of classes, set up information tables, meet students in the parking lot, and welcome students to the college.
