Summer and Fall 2024 Enrollment Update

As of **Monday, June 24, 2024**, Compton College has generated:

- 546 FTES for the **Summer 2024** term. The fill rate is currently 75%, and the seats filled is 4,498.
- 782 FTES for the **Fall 2024** semester. The fill rate is currently 29%, and the seats filled are 4,958.

The second six-week session begins **Monday, July 1**. Students may register for classes through 11:59 p.m. Sunday via MyCompton; after the first class meeting, they will need an authorization code from the instructor to add the class.

Certified Nursing Assistant Certificate of Competency

The California Community Colleges Chancellor's Office approved the Certificate of Competency in Certified Nursing Assistant. The Academic Affairs Office will be entering the instructional program into Banner and updating the Catalog to reflect program requirements. We will start offering the noncredit CNA courses in fall 2024 so students can begin earning this certificate. This program is not financial aid eligible. Click [here](#) to read the letter.

ACCJC Substantive Change Approval

On January 29, 2024, the College received notice that the [ACCJC Policy on Substantive Change](#) was updated and that the College would need to submit another Distance Education Substantive Change. The [application](#) addressed components necessary for Compton College to continue offering programs online. The Accreditation Faculty Coordinator and the Vice President of Academic Affairs drafted responses to the questions, which were shared with the [Accreditation Steering Committee](#), [Distance Education Advisory Committee](#) (DEAC), [Academic Senate](#), and [Compton Community College District Board of Trustees](#). The DEAC approved the application on April 30, 2024, the Academic Senate approved it on June 6, 2024, and the [Board of Trustees approved it on June 18, 2024](#). On June 25, 2024, the College received notification that the [ACCJC approved our Distance Education Substantive change application](#).
