Subject: President/CEO Message - January 31, 2025

## Campus Community,

This week, Compton Community College District Board of Trustees members and I met with elected officials and key stakeholders at the California state capitol to discuss educational policy and the <a href="2025 Compton">2025 Compton</a>
<a href="Community College District Legislative Priorities">Community College District Legislative Priorities</a> (State). The discussions focused on supporting AB540 and non-traditional students, addressing the nursing shortage in Los Angeles County, and managing rising construction costs for current and upcoming projects. We also highlighted efforts to meet the basic needs of students, such as housing, food security, and mental health services. We explored opportunities to expand cross-enrollment programs with local California State Universities (CSUs). Additionally, questions were addressed about how credit for prior learning fits into the <a href="California Master Plan for Career Education">Career Education</a>, emphasizing its importance in recognizing students' previous experiences and accelerating their educational progress, with many voicing concerns about setting standard criteria for evaluation that ensures equity.

The meetings with our elected officials and key stakeholders were very productive and provided a platform to advocate for the needs and priorities of Compton College and its students. Over the next couple of weeks, we will prepare various follow-up items to share with them.

### **Spring 2025 Enrollment Update**

As of *yesterday, January 30, 2025*, Compton College has generated 1,374 FTES for the Spring 2025 term. Our fill rate for Spring is currently 58%, and 9,661 seats are filled.

I am always concerned about enrollment, even though Compton College is seeing an increase for spring 2025. Please keep sharing enrollment information with current and prospective students. For registration assistance, refer students to the Welcome Center in the Student Services Building.

# **Immigration Enforcement Reminder**

Compton College remains steadfast in its commitment to providing a safe and inclusive learning environment free from harassment and discrimination. To uphold this commitment, on *January 17*, *2025*, we issued Administrative Regulation 3415 - Immigration Enforcement Activities, which aligns with Board Policy 1200 – Mission and Vision.

This regulation outlines our legal responsibilities as a California higher education institution when dealing with immigration officers or agents on campus or when receiving subpoenas or warrants related to immigration enforcement. All employees need to understand these obligations to ensure compliance with the law while supporting our community.

Administrative Regulation 3415 - Immigration Enforcement Activities was shared with the UndocuAlly Task Force and the Consultative Council. The Compton CCD Board of Trustees reviewed it at their *January 13*, 2025 meeting. The new Administrative Regulation 3415 - Immigration Enforcement Activities went into effect on *January 17*, 2025. An email communication informed students and employees about the new protocols.

Beginning in *February 2025*, we will send a monthly communication regarding immigration enforcement activities and pertinent information for employees and students. # 2025-2026 Compton Community College District Budget Development

As mentioned in the <u>President/CEO Message – January 17, 2025</u>, Governor Gavin Newsom released his <u>proposed budget for the 2025-2026 fiscal year</u>, and the impact on California Community Colleges is outlined in the <u>Chancellor's Office Joint Analysis of the proposed budget</u>. As mentioned in the <u>President/CEO Message – January 24, 2025</u>, this past week, Vice President of Administrative Services, Dr. Abdul Nasser, shared the <u>Budget and Planning Timeline for 2025-2026</u>, the <u>2025-2026 Tentative Budget Assumptions</u>, and the updated <u>Five-Year Fiscal Management Plan</u> with the <u>Planning and Budget Committee</u>.

The <u>2025-2026 Tentative Budget Assumptions</u> include the Governor's proposed 2.43% Cost of Living Adjustment (COLA), apportionment based on the generation of 5,980 FTES (Hold Harmless), filling two full-time faculty positions, including the Culinary Arts and Fire Technology Instructor positions, and funding for PERS, STRS, and utility increases. As mentioned in the <u>President/CEO Message – January 24, 2025</u>, for the 2025-2026 year, we are targeting 4,442 Full-Time Equivalent Students (FTES) and offering 1,476 sections. The 2025-2026 Compton CCD Budget Development will be discussed at the next <u>Consultative Council meeting</u>.

# **Compton Community College District Board of Trustees Retreat**

The Compton CCD Board of Trustees will hold a retreat on *Monday*, *February 3*, *2025*. The Board will discuss progress toward its goals for *July 1*, *2024*, *through June 30*, *2025*, and review and discuss their vision statement. The retreat will be held in the Student Services Building, Room 212.
