### **Mission Statement for the Cosmetology Department**

Compton College's (CC) Cosmetology Department provides innovative instruction and quality pedagogical methods designed to support students in pursuing successful careers in the exciting area of cosmetology. We offer advanced career training to foster student licensure attainment through the State Board of Barbering and Cosmetology and prepare students to secure lucrative employment in the beauty industry.

### **Program Description**

The CC Cosmetology Department is part of Business and Industrial Studies Division and provides multiple learning environments by applying innovative instruction in the diverse domains of cosmetology. The program prepares students for the opportunity to earn the 1,000 hours of classroom instruction, in both lecture and lab learning environments, which are required to qualify for the written exam to gain licensure through the California State Board of Barbering and Cosmetology.

### **The Students We Serve**

We proudly serve students from diverse backgrounds in our local urban community and provide them with the necessary tools to enter the workforce to foster them gaining financial autonomy. The CC district includes the city of Compton and serves the areas of Lynwood, Paramount, Willowbrook, Athens, Bellflower, Carson, Downey, Dominguez, Lakewood, Long Beach, and South Gate.

**Describe the degrees and/or certificates offered by the program.**

### **Program Degree and/or Certificate Offered**

In addition to preparing students for licensure through the State Board of Barbering and Cosmetology, our program offers students an opportunity to earn an A.S. Degree in Cosmetology, a Cosmetology Level I: Certificate of Accomplishment, and a Cosmetology Level II: Certificate of Achievement.

**Catalog Description:**

The Cosmetology Level II Certificate of Achievement gives students 1,000 hours to prepare them to take the California State Board of Cosmetology written examination. Competencies are assessed regularly in compliance with the California State Board of Barbering and Cosmetology criteria. After successful completion of the California State Board of Barbering and Cosmetology's cosmetology written examination, students will have a state license to embark on their new career.

Note: Students who do not complete a minimum of 1000 hours with the required core courses will need to take additional class(es) to apply for their state board written exam and be certified to do so. The following classes are offered to assist students in reaching their 1000 hour requirement: COSM 95 (1-3), COSM 114 (8) Fall/Spring, COSM 125 (4) Summer, COSM 126 (2) Winter, COSM 130 (6) Summer, and COSM 140 (4) Winter.

**Catalog Description:**

The cosmetology program offers students the option to gain proficiency in hair cutting, coloring, permanent waving, chemical relaxing, manicuring, pedicuring, and facials. After completing introduction to cosmetology, Cosmetology Level I (Certificate of Accomplishment), students will have the basic skills for entry-level positions as specified by the State Board of Cosmetology. Completion of Cosmetology Level II (Certificate of Achievement) will give students 1,000 hours and prepares them to take the California State Board of Cosmetology Examination. Competencies are assessed regularly in compliance with the California State Board of Cosmetology criteria. After successful completion of the California State Board of Cosmetology Examination, students will have a state license to embark on their new career.

**Explain how the program fulfills the College's mission and aligns with the strategic initiatives.**

### **Program Fulfillment of Compton College's Mission and Alignment with Strategic Initiatives**

CC's Cosmetology Department opened in Fall 2016 and continues to offer excellent pedagogical methodologies implemented by highly qualified licensed cosmetology instructors. These advanced instructional techniques include online technology learning platforms, field trips, demonstrations, business acumen applications, group projects, individual projects, written exams, practical assessments, and leading guest speakers in the cosmetology field. All of these innovations help prepare our students for successful careers. As a result, and in alignment with the program's mission, these practices best support CC's vision of being a leading institution for student learning and success in higher education. The CC Cosmetology Department proudly welcomes all students from the local community and provides valued services to neighboring patrons; this, in turn, reinforces CC's mission to be a welcoming and inclusive environment where diverse students are supported to pursue and attain success. Our program provides a well-defined vocational pathway allowing cosmetology students to attain professional licensure and career success. This reflects another component of CC's stated mission to prepare students to earn a living wage.

### **Alignment with Strategic Initiatives**

CC's five strategic initiatives are:

1. Improve recruitment, enrollment, retention, and completion rates for our students;
2. Support the success of all students to meet their education and career goals;
3. Support the success of students through the use of technology;
4. Offer excellent programs that lead to degrees and certificates in allied health and technical fields; and
5. Establish partnerships in the community and with K–12 schools.

### **Recruitment, Enrollment, Retention, and Completion Rates for Our Students**

In the areas of recruitment, enrollment, retention, and student completion rates, our program offers a unique opportunity for students to specialize in the exciting field of cosmetology. The program consists of a day and an evening program. In any given 16-week semester, the day program can provide 16 units of instruction to each of 24 full-time freshman students, and each of the 32 students on the clinic floor may be provide 8 units in any given 8-week session within a semester. The evening program can provide 8 units of instruction per semester to each of 24 freshman students, and 8 units to each student graduated to the clinic floor. Additionally, our Paramount Adult School (PAS) satellite location provides an additional 8 units per semester to each of the 24 freshman and sophomore students.

The program supports recruitment because it is a popular program of interest to students graduating from local high schools or those needing to retool to enter the workforce. During high school visits to CC's campus, the doors to the Cosmetology Department remain open for tours, and faculty, staff, and cosmetology students provide information to local youth regarding the cosmetology program. Advanced instructional techniques continue to foster strong student learning outcomes, with correspondingly high program completion rates and licensure attainment. Students who have earned certificates and degrees participate in CC's graduation ceremonies.

### **Support the Success of all Students to Meet their Education and Career Goals**

In support of this initiative, our program provides a diverse curriculum in the domains of cosmetology: chemical waving, chemical straightening, color applications, hair cutting, skin care, nail care, blow drying, waxing, braiding, and wet-hair styling. Our up-to-date, comprehensive instructional techniques across these broad domains—encompassing visual, auditory, and/or tactile instruction—encourage all student learners, whatever their learning style.

### **Support Student Success Through the Use of Technology**

In this area, we provide each student instructional benefit through the supplemental use of Canvas. This online learning tool allows students to communicate online with instructors regarding posted syllabi, calendars, assignments, and exams; its live platform provides grade posting transparency in real time and allows for students to join assigned online peer discussion arenas. Instructors in the Cosmetology program use Milady PowerPoint presentations when instructing theory courses. Further online support is offered through MiladyCIMA, whereby students complete final chapter exams and matching, true or false, and multiple-choice exercises. The combination of these online tools fosters student success, high academic course completion results, licensure attainment, and program completion.

### **Offer Excellent Programs that Lead to Degrees and Certificates in Allied Health and Technical Fields**

In support of this initiative, our program offers a Cosmetology - A.S. Degree, a Cosmetology Level I Certificate of Accomplishment, and a Cosmetology Level II Certificate of Achievement. The cosmetology program is vocational in nature; its mission statement is to prepare students to attain cosmetology licensure through the State Board of Barbering and Cosmetology and to secure sound financial employment in the beauty industry.

### **Establish Partnerships in the Community and with K–12 Schools**

The CC Cosmetology Department actively participates in campus visits from high school and middle school students, fostering a robust pipeline. In Spring 2019, the Cosmetology Department partnered with PAS to open the new cosmetology program satellite campus. Offering beauty services to our local community is an honor, and clinic floor patronage has developed substantially; this opportunity allows our students to complete real services for patrons, build their self-esteem, and prepare for job placement. Our faculty invites industry leaders from surrounding areas to exhibit current trends through live demonstrations, as well as providing field trip opportunities throughout Los Angeles County. Inviting area industry professionals to our Advisory Committee meetings enables us to update our curriculum design to incorporate the latest industry trends.

### **Discuss the status of recommendations from your previous program review.**

#### **Administrative Organization**

At CC, the Cosmetology Department is under the supervision of the division chair of the Business and Industrial Studies division, who, in turn, reports to the dean of the Business and Industrial Studies division. All divisions are accountable to the vice president and president of CC.

Our program consists of full-time and adjunct faculty who instruct in accordance with the official institutional course outlines of record approved by the CC Curriculum Committee. Representatives of CC serve on this committee in its task of periodically reviewing and updating course content, approving new program courses, and approving textbooks. A full-time cosmetology professor from the CC Cosmetology Department regularly attends the committee to speak on behalf of the program and keep up to date on the vocational curriculum criteria required by relevant state agencies.

#### **Distance Education**

All cosmetology courses, not including COSM 95, are approved for emergency fully online by mutual agreement:

#### **Emergency Fully Online by Mutual Agreement Statement**

A course may be offered fully online when the president of the college issues a state of emergency. The dean and division chair shall rely primarily on the assigned faculty for a recommendation to provide the course(s) entirely online for the present and/or subsequent semesters/terms. The District and the assigned faculty shall mutually agree upon the implementation of the fully online course(s).

### **Discuss how well the courses, degrees, or certificates meet students' transfer or career training needs.**

#### **Course, Degrees, Certificates, and Licensure**

Cosmetology courses offered support cosmetology student career training needs and are designed as a CTE guided pathway toward cosmetology licensure through the State Board of Barbering and Cosmetology. The State Board of Barbering and Cosmetology offers a written exam to earn cosmetology licensure. Recently, the state decreased the number of clock hours required to apply for licensure from 1,600 to 1,000. Additionally, the practical exam was eliminated. The programs in Curriqnet have been revised to reflect these changes, meeting CCC, AS, and BOT approvals.

### **How many students earn degrees and/or certificates in your program? Set an attainable, measurable goal related to student completion of the program's degrees/certificates.**

#### **Degrees and/or Certificates Awarded**

The following data is available to view in the *Program Awards by Compton College Institutional Effectiveness*. A combined total of 90 degrees and certificates have been awarded from 2017 through 2021. In 2017-2018, 12 certificates were awarded. In 2018-2019, 31 certificates were awarded. In 2019-2020, 21 certificates were awarded. In 2021-2022, 8 certificates and 12 degrees were awarded. It is important to note, since not all students may apply for the Cosmetology Level I: Certificate of Accomplishment, Cosmetology Level II Certificate of Achievement, and Cosmetology - A.S. Degree, the degree/certificates awarded may be lower than the number of students meeting degree/certificate requirements. As a result, it is essential for a certificate/degree student process be followed/established so all cosmetology students are awarded a certificate/degree meeting certificate/degree requirements. It is likely, there are students that have met the certificate/degree requirements that have not completed the necessary paperwork to be awarded the certificate/degree. It is recommended that cosmetology students meeting certificate/degree requirements, that have not completed the necessary paperwork to receive the certificate/degree, be contacted to initiate the paperwork/process.

### **Attainable/Measurable Goal Related to Student Completion of the Program's Degrees/Certificates**

The goals are based on potential enrollment and the number of student completions. For example in the Compton College Freshman Day COSM - 101, there are 24 seats available. However, the number completing may be less, at 18 per semester. At the Freshman Day Paramount COSM - 105, approximately 8 students per semester may be enrolled, and the Compton College Freshman Evening COSM -105 approximately 8 students per semester may be enrolled. Combining potential enrollment and potential student completions among the three freshman courses, it is reasonable to expect 34 students to meet the Cosmetology Level I: Certificate of Accomplishment requirements per semester. If approximately 85% of the 34 freshman students matriculate/pass COSM - 112, 28 students may meet the requirements to earn the Cosmetology Level II: Certificate of Achievement per semester. Cumulatively, 62 certificates may potentially be awarded per semester and 104 annually. However, this total will rely on refining the process for students to complete necessary paperwork that have met certificate requirements, as well as, student enrollment. Hypothetically, if 20% of the 28 students awarded the Cosmetology Level II: Certificate of Achievement completed the necessary GE requirements for the Cosmetology - A.S. Degree, than 5.6 students could earn a degree per semester, or 11 annually. It is important to note, the data available in the *Program Awards by Compton College Institutional Effectiveness webpage* for both cosmetology certificates are not disaggregated.

### **Recommendation**

Streamlining the process for students to receive their certificates upon reaching program requirements would foster increasing the number of certificates achieved. Hiring a coordinator to oversee certificate processes as a primary duty would assist achieving this aim.

**Summarize the SLO and PLO assessment results over the past four years and describe how an analysis of those results led to improved student learning. Analyze and describe those changes. Provide specific examples.**

In 2023 Cosmetology 101 SLO data obtained from Spring 2021, Fall 2021, Spring 2022, and Fall 2022 was assessed by means of a written faculty report. The data collected assessed the performance of 130 student outcomes with three SLO statements. In this introductory course, it was expected that 90% of students will perform at least 70% or better on assessments aligned with the stated SLO's. Students participate in practical assessment by means of skill demonstration performing cosmetology services with live chemicals and simulated products on human hair mannequins to produce a real result. The data collected shows the following results:

- SLO 1 – 94.29% of students passed with a score of 70% or higher
- SLO 2 – 95.29% of students passed with a score of 70% or higher
- SLO 3 – 92.86% of students passed with a score of 70% or higher

An analysis of this data reflects 94 % of the students are within acceptable level for understanding by scoring at least 70% or higher on the assessed material. There were no significant patterns observed by the disaggregated data by mode of instruction, race/ethnicity, and or gender. Factors that impacted the assessment results include lectures, demonstrations, and student practice. This analysis has led to improved student learning by 81% of students passing the course with a 70% or higher and matriculating to the subsequent course in the program.

The college has not assessed PLO's, and therefore PLO assessments results were not analyzed.

**Describe how you have improved your SLO/PLO assessment process and engaged in dialogue about assessment results.**

Full-time faculty met in 2022 to analyze SLO statements that accurately reflect course outcomes. Faculty engaged in discussion and provided input to update student learning outcomes in most program courses. SLO statements were updated to include action verbs using Bloom's taxonomy to properly address student learning. SLO statements were reduced from 3 SLO statements per course to 1 SLO statement per course. Faculty are set to revisit updated SLO's for effectiveness in 2024 and make recommended changes.

The college has not assessed PLO's, and therefore PLO statements were not discussed.

**List any related recommendations.**

The following recommendations will be discussed among full-time faculty:

1. Increase the standards for success from 70% to 80% based on the CA Cosmetology Licensing Exam passing score of 75% or higher.
2. Combined courses to have a minimum of 3 SLO statements to assess student learning accurately among courses with 2-4 combined courses.

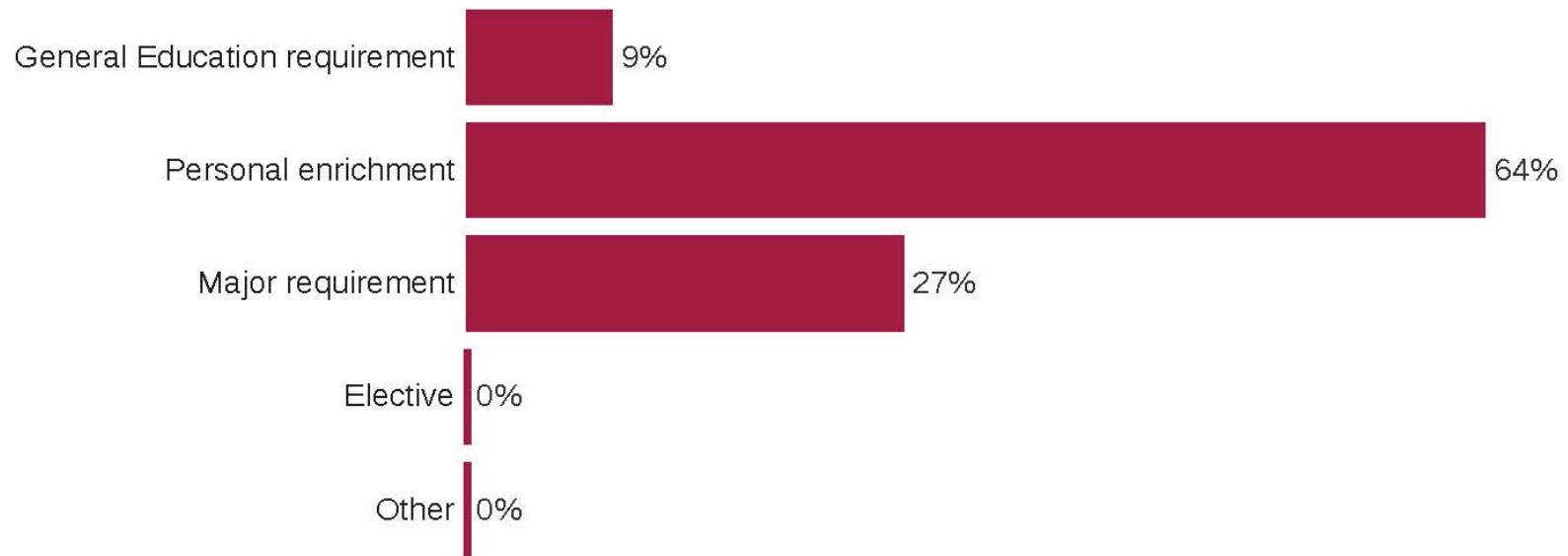

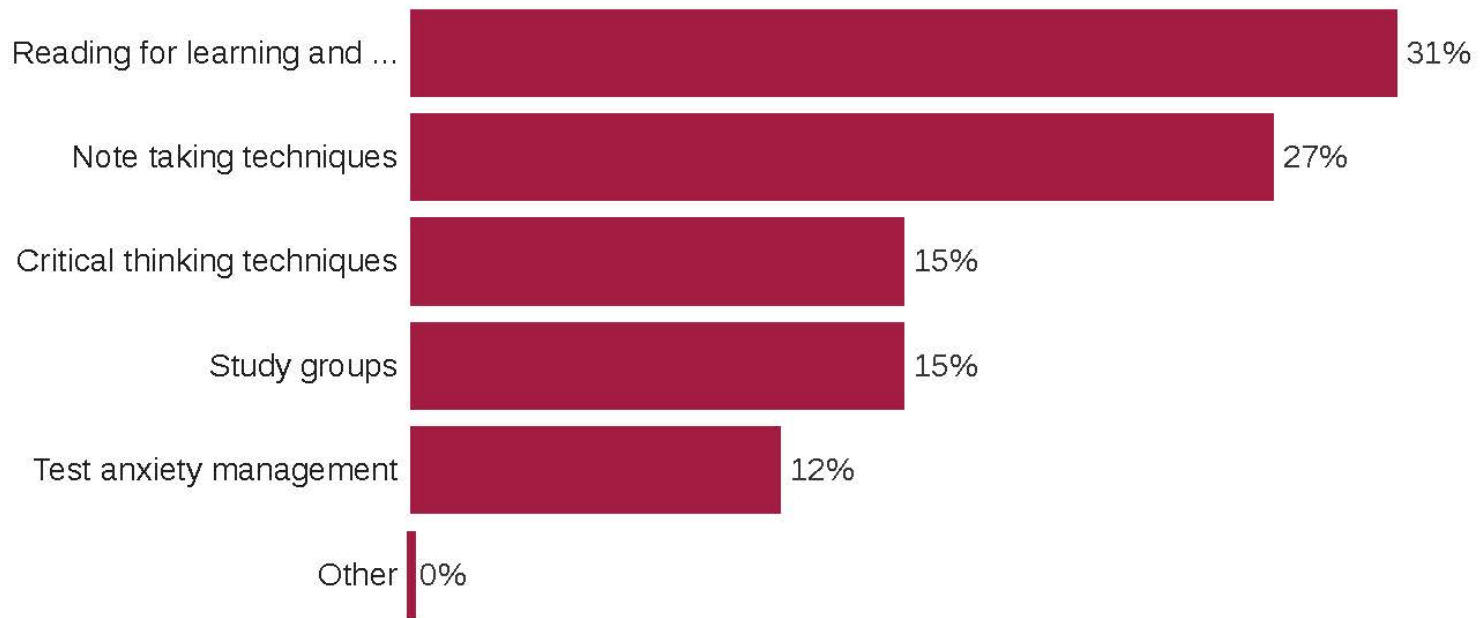

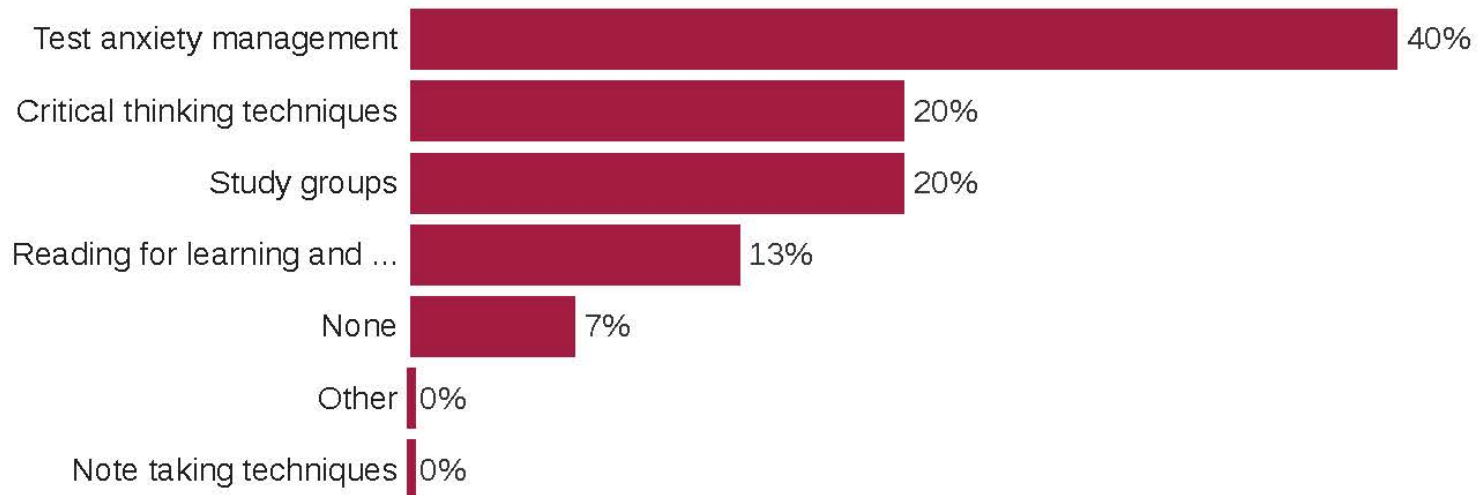

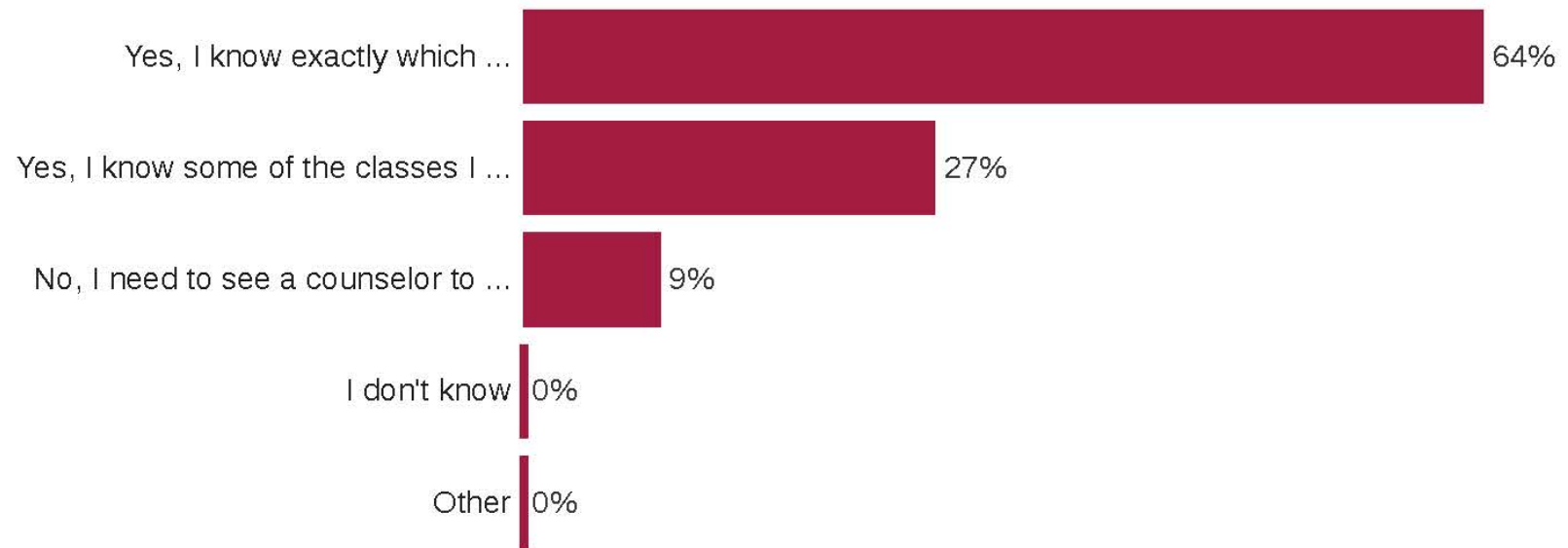

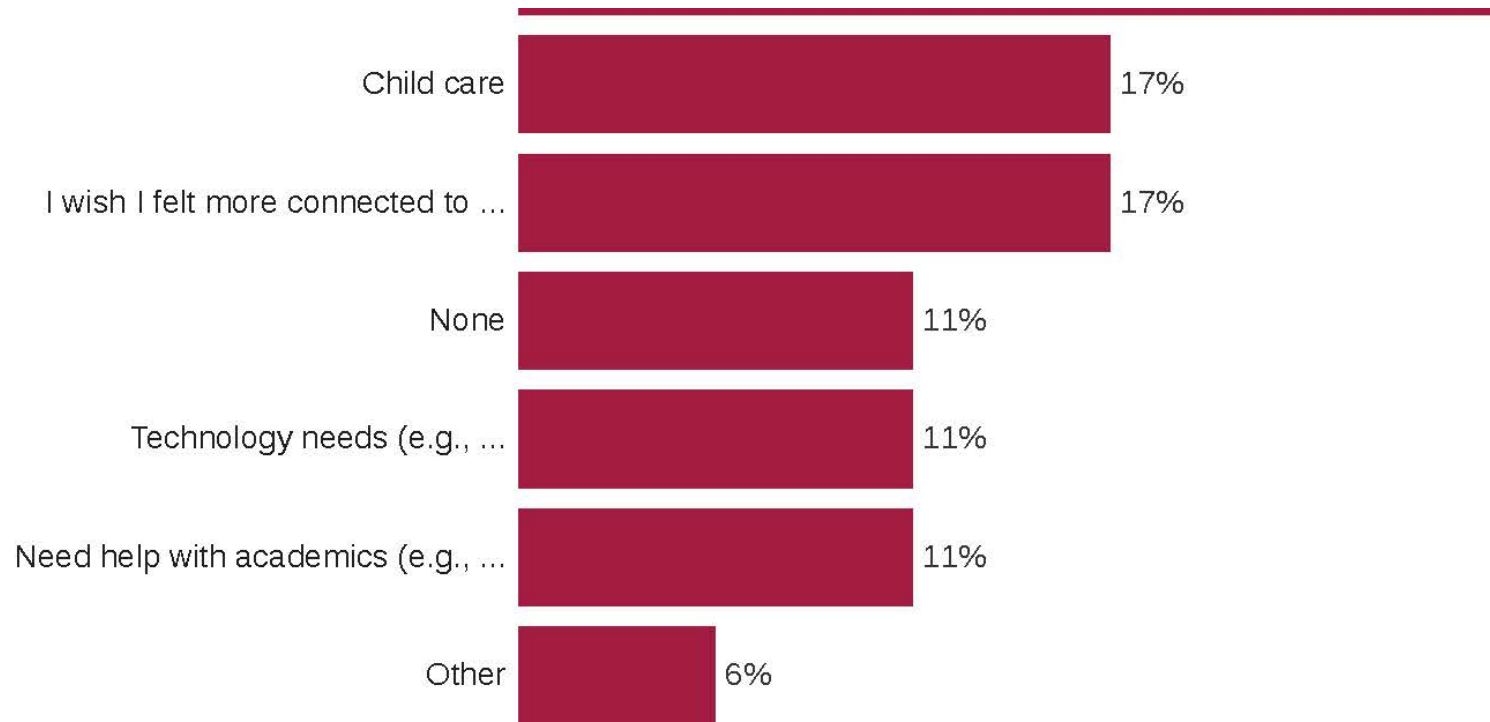

Analysis of the student survey results that the majority of students feel supported in the cosmetology program by faculty, staff, and counselors. The majority of students expressed a good understanding of the program courses and what is needed to complete their course of study, however almost half of students unsure of a definite career goal. Reading, notetaking are the skills needed most in the program, and students need more support with test anxiety management, critical thinking, and working in study groups most likely in anticipation of the CA Cosmetology Licensing Examination.

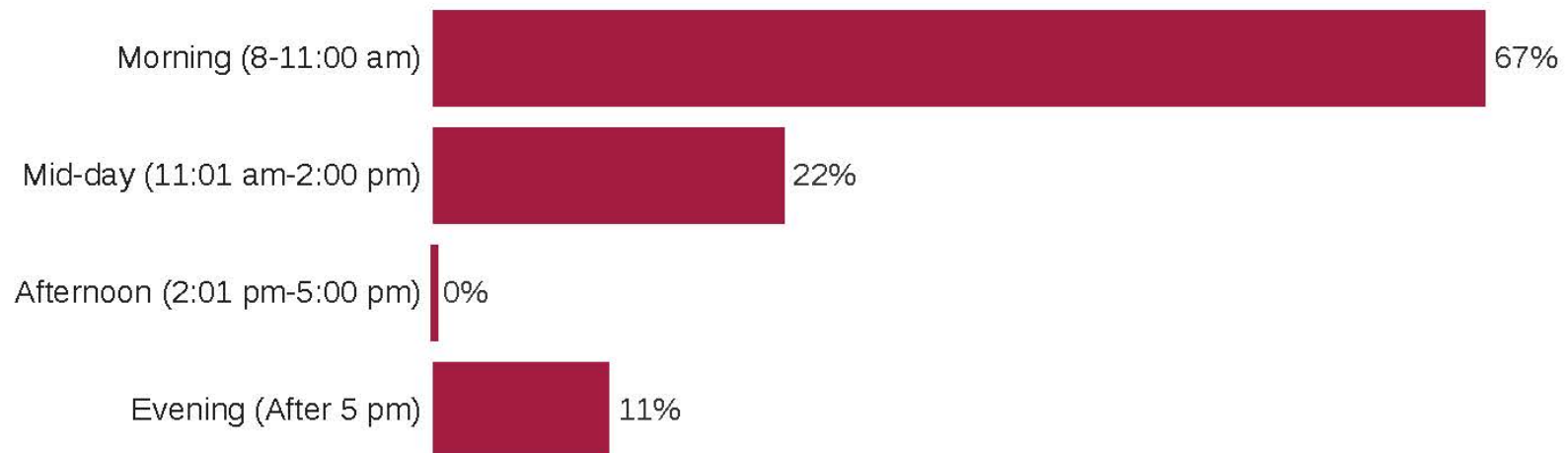

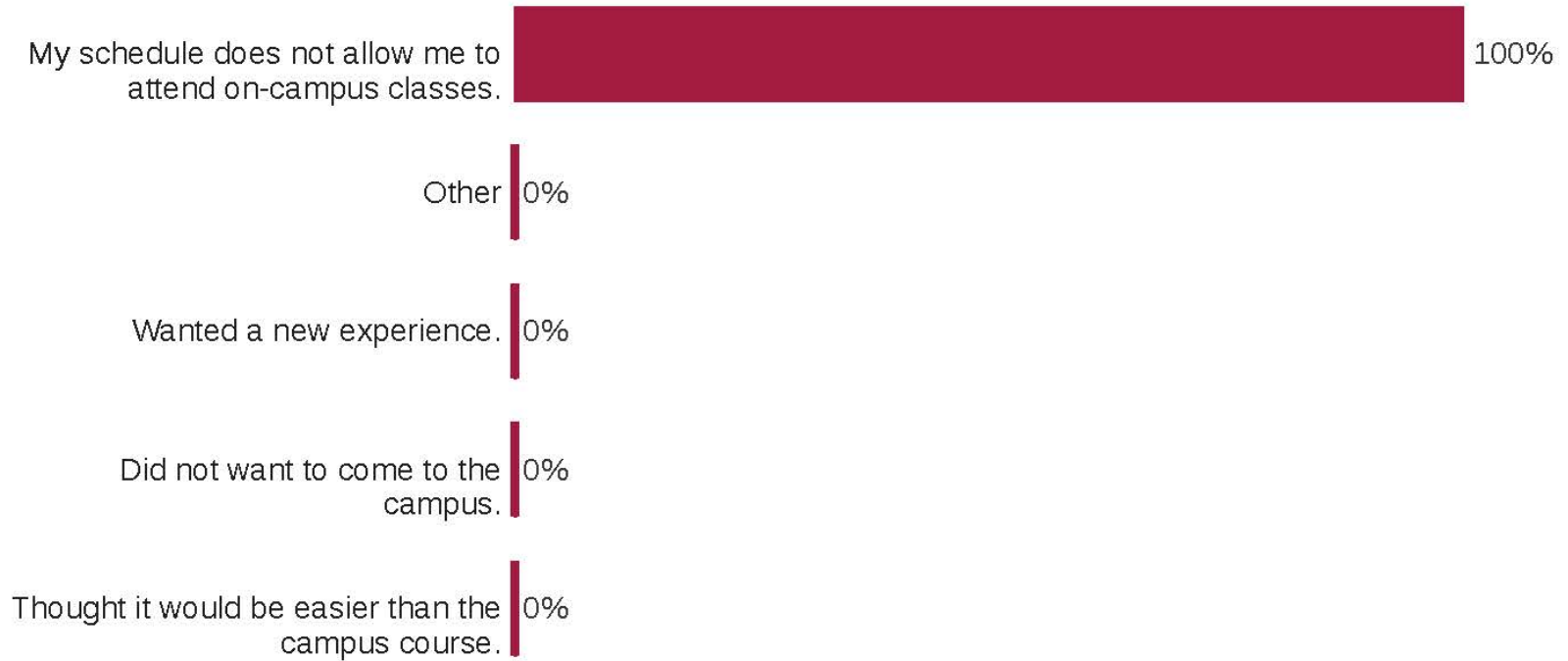

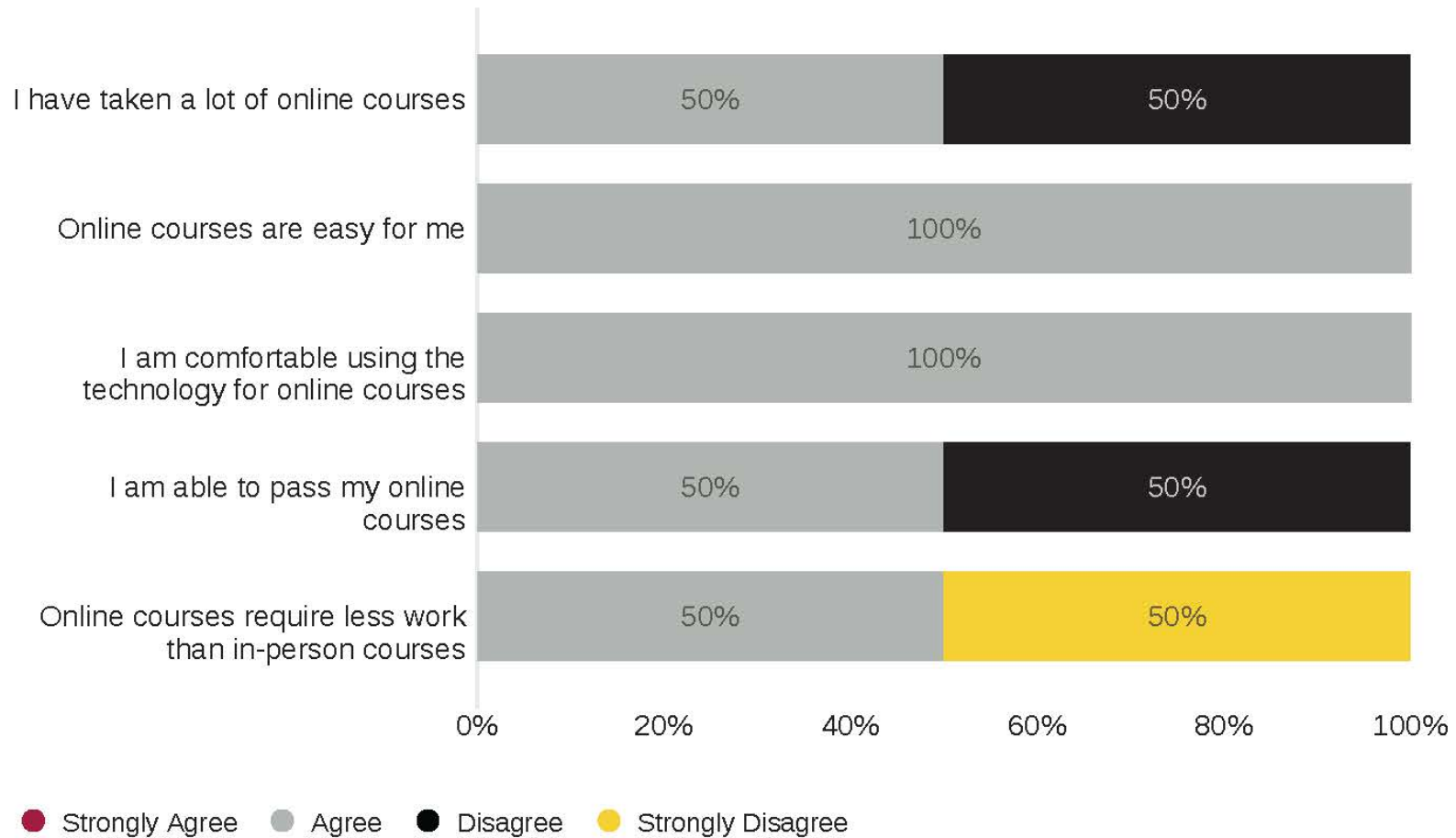

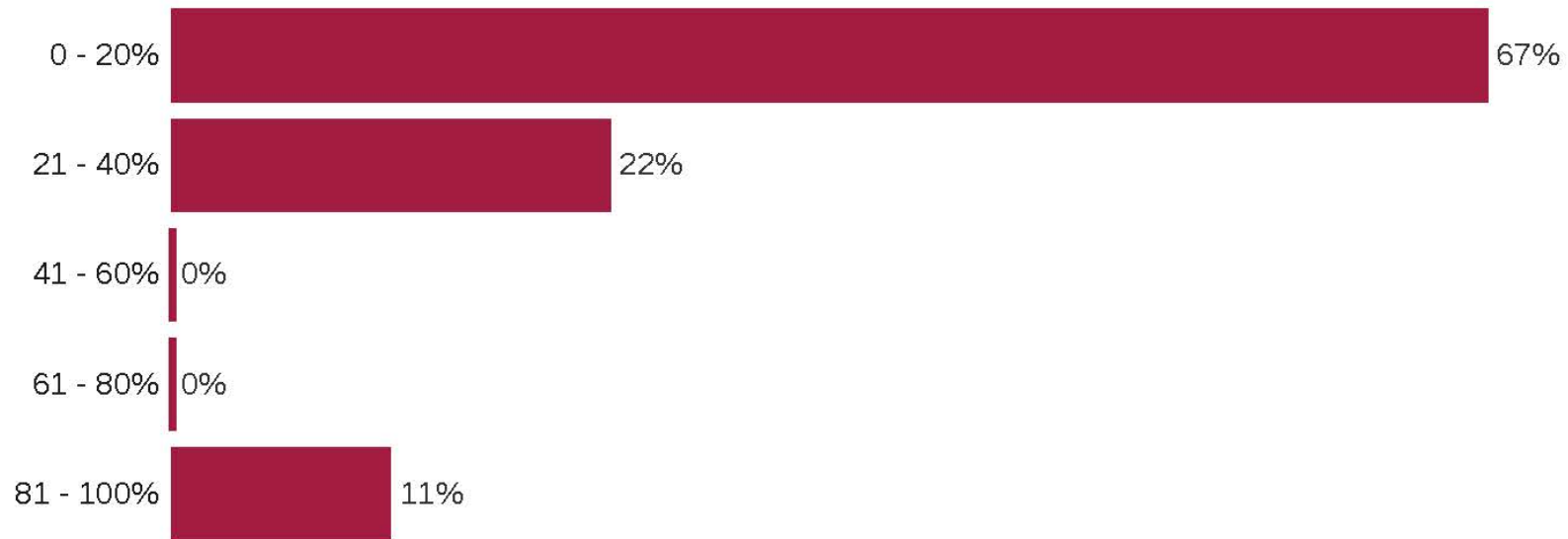
Please rate how much you agree or disagree with the following statements about online courses in the program

Of the nine responses collected:

- In regards to time of day to take courses 67% of our students prefer to take courses in the morning, 22% of students prefer to take courses in the midday, and 11% if students prefer to take courses in the evening. No students prefer to take courses in the afternoon.
- In regards to teaching methods 56% of students prefer to classes 100% in person on campus, where 44% prefer to take hybrid courses
- 11% of students disagree with the statement "I've been able to register for the classes I need within this program.", while 33% of students agree and 56% of students strongly agree with the statement "I've been able to register for the classes I need within this program."
- 22% of the students have enrolled in an online class before and 78% of the students have not enrolled in an online class before.
- 67% of students are taking 20% or less online courses, 22% of students are taking 21% - 40% online courses, 11% of students are taking 81% - 100% online courses.

Of the two responses collected:

- 50% of students agreed with the statement "Online courses require less work than in-person courses.", while 50% of students strongly disagree with this statement.

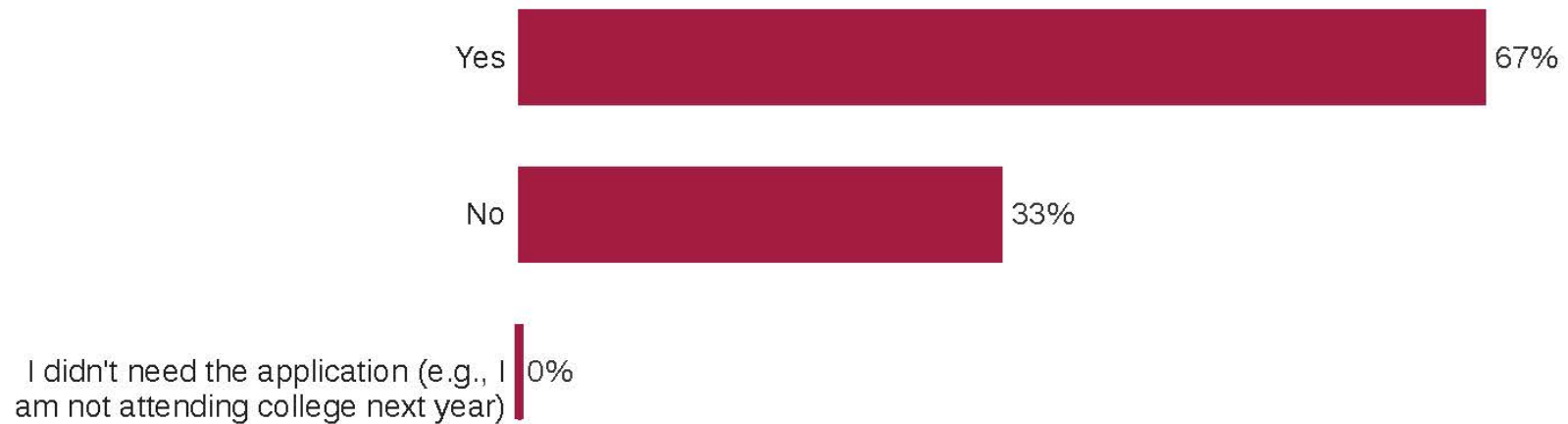

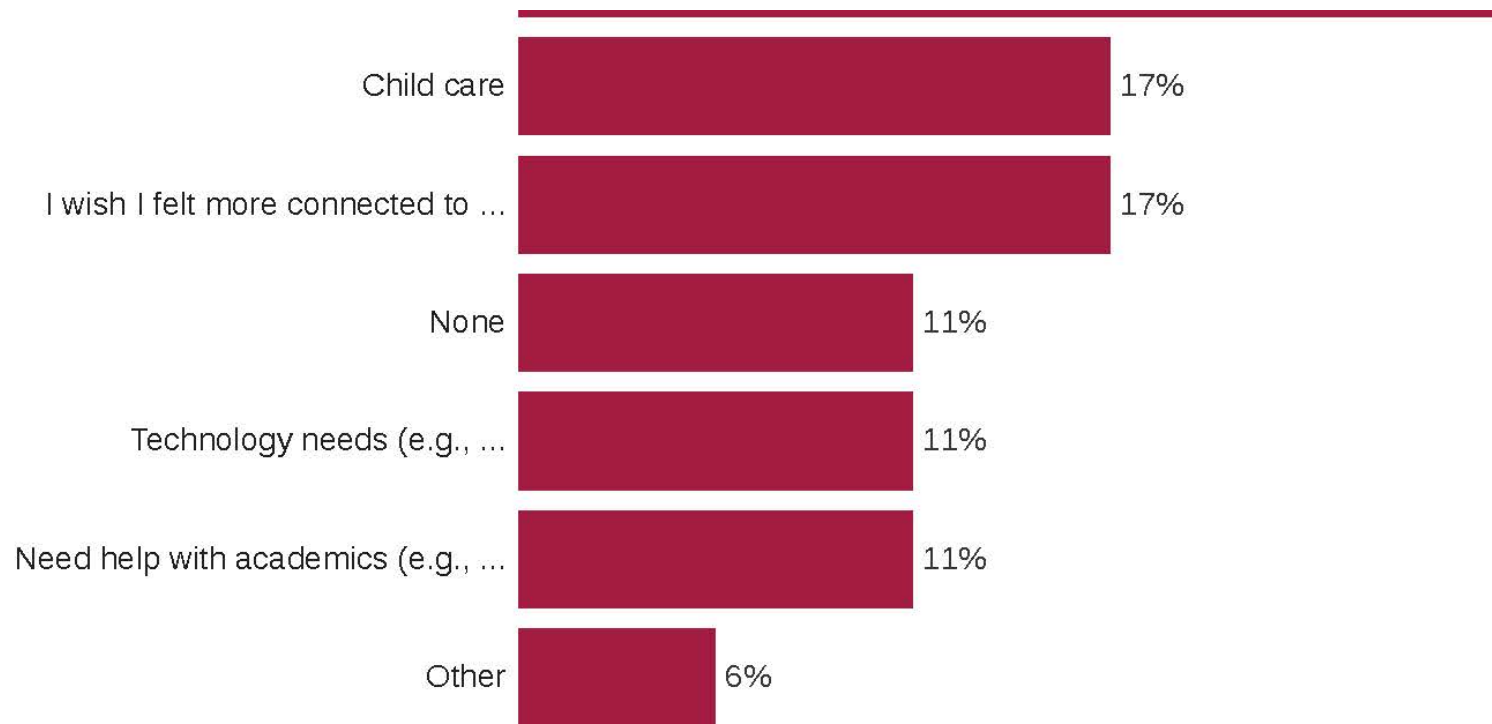

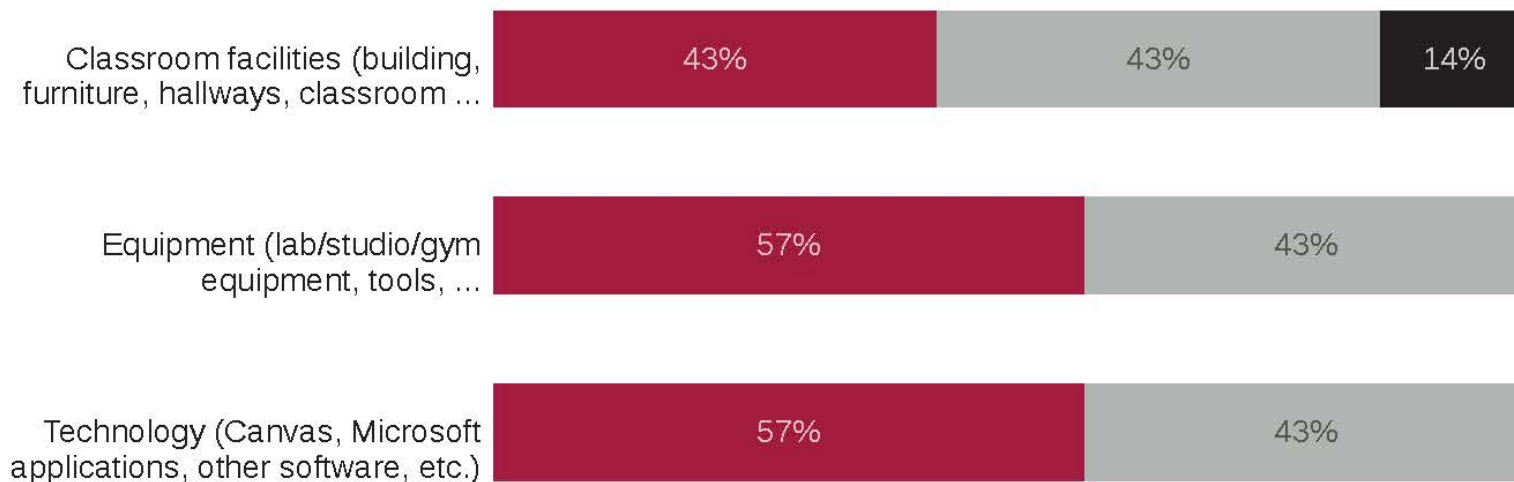

- 14% of students found the classroom facilities to be poor, while 43% of students found the classroom facilities to be satisfactory, and 43% excellent
- 43% of students found the equipment and tools to be satisfactory, while 57% of students found the equipment and tools to be excellent
- 43% of students found the technology applications and software to be satisfactory, while 57% of students found the technology applications and software to be excellent.

Analysis of the student surveys reflect that less than half of students surveyed found classroom facilities to be in excellent condition, with 14% of students describing classroom facilities as poor. The majority of our students found the equipment, tools, technology applications, and software to be in excellent condition.

- 78% of students agree with the statement "I am aware of the course outcomes- what I should be able to learn and what skills I should possess after completing courses in the program.", while 22% of students strongly agree.
- 67% of students agree with the statement "After taking this program's course, I am much more knowledgeable about the subject than before.", while 33% of students strongly agree.

Analysis of the student surveys reflect the majority of students to have a good understanding of the course outcomes and believe they are more knowledgeable about the subject after taking the courses in the cosmetology program.

The survey does not differentiate between the students of the on-site program at Compton College and the off-site program at Paramount Adult School. Results in areas of facilities and equipment cannot be accurately analyzed.

1. Almost half of the students surveyed would prefer a hybrid version of our program. This may be due to the 5 - 7.5 daily clocked hour requirements for all courses in the Cosmetology program that interferes with students work/life balance and responsibilities. It is recommended to review the idea of offering theory hours online while maintaining the lab portion of our courses in-person
2. The program review survey can be further tailored to differentiate among the two campuses with specific questions related to Cosmetology Program students. 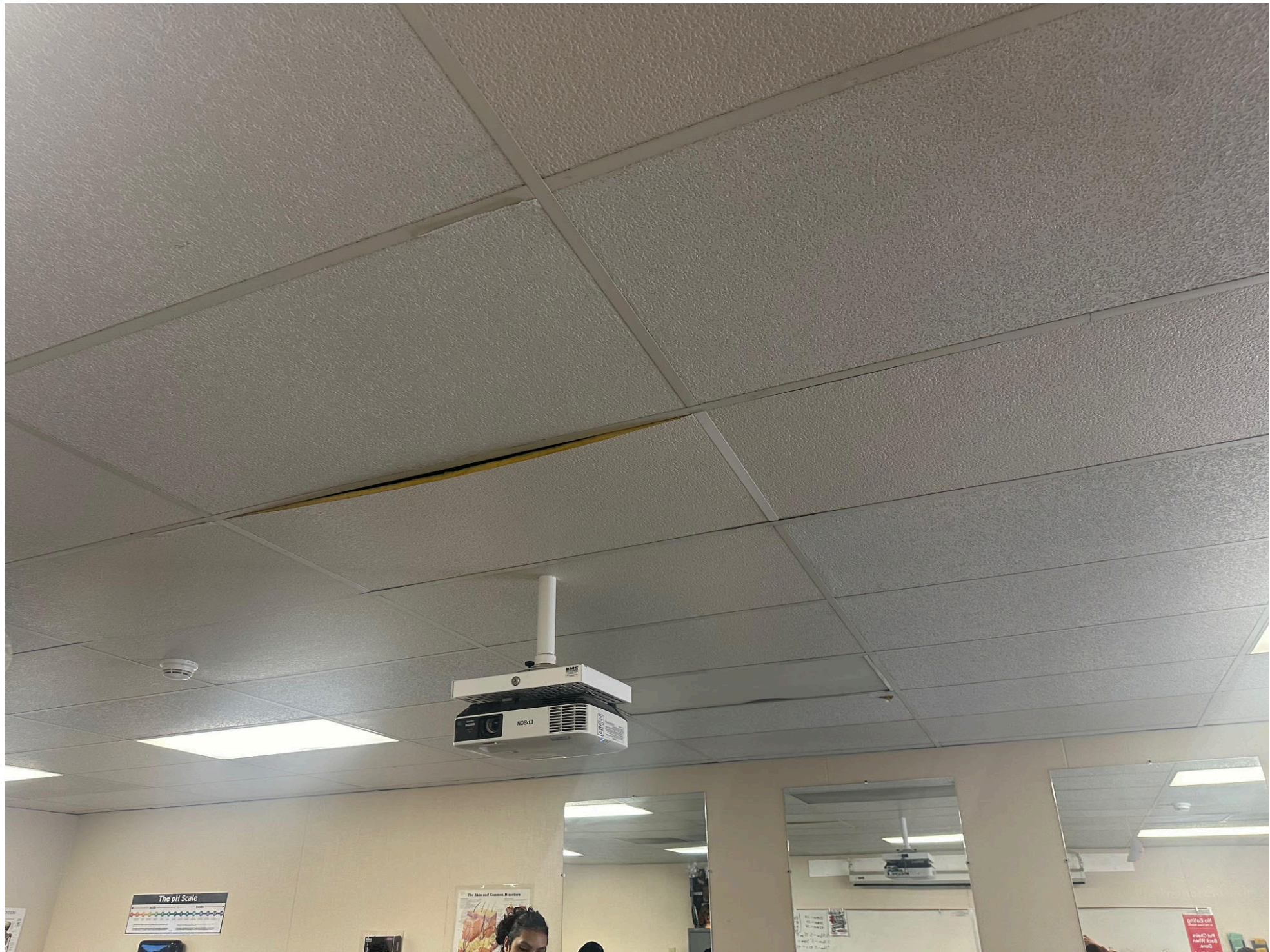

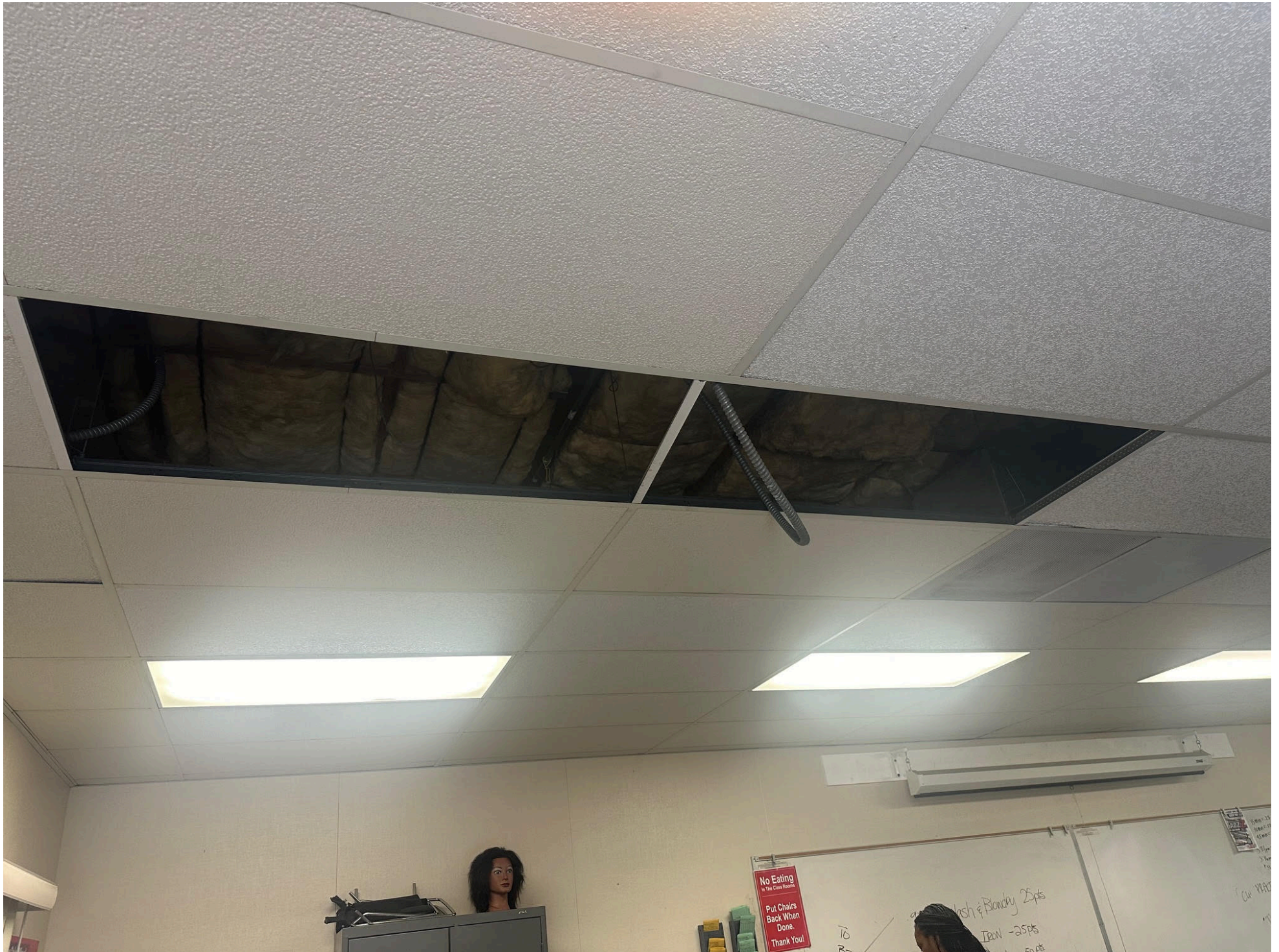

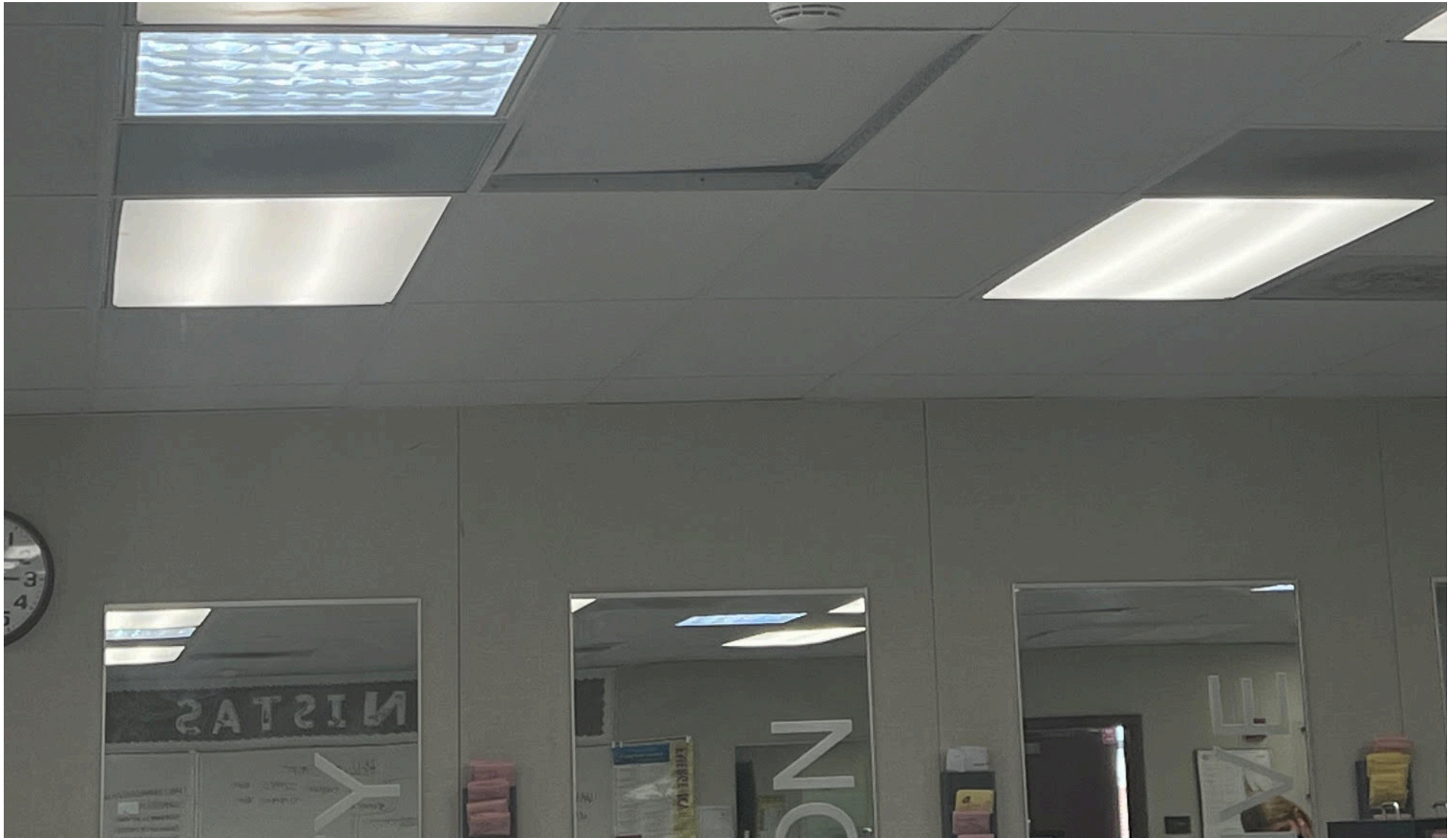

**Immediate Staffing Needs and Recommendations (1–2 years)****Coordinator**

It is common among CCC Cosmetology Programs to have a coordinator. Provided the growth and size of our program, which includes the CC day and evening program and the PAS day off-site location, we require a coordinator to maintain consistency within our program. A coordinator contributes to the department running smoothly and their duties may include, yet not limited to, ordering kits, ordering books, scheduling field trips, and acting as a liaison between our department and other campus departments. Filling a coordinator position would cost approximately \$45,000.

**Full-time Teaching Aid**

Additionally, having a full-time cosmetology aide to share between rooms TV-1 and TV-4 would benefit the quality of one on one instruction provided to all students at a cost of approximately \$45,000.

**Part-time Bonded Cashier**

We have had the wonderful opportunity to employ CC students through CaL/WORKS to run our front desk. Although they have been an asset to our department, it would benefit the program to add an additional permanent bonded cashier position for our growing clinic floor. When we do not have Cal/WORKS student to run the front desk, enrolled students run the front desk. Due to the the high volume of cash we collect, it would be best if the cashier position was held by an official licensed and bonded part-time classified staff member at an annual cost of approximately \$22,000.

**Fourth Full-time Cosmetology Instructor**

It is recommended that a fourth full-time cosmetology instructor is hired to ensure freshman courses have a full-time instructor to lead the courses at an annual cost ranging from \$59,588.00 to \$89,569.00.

**Staffing Needs and Recommendations (2–4+ years)****Esthetics Instructor**

As our department grows, and new infrastructure is completed, we remain open to offering an esthetics program. The programs would require an additional full-time esthetics instructor, at an annual cost ranging from \$59,588.00 to \$89,569.00. The esthetics program would serve as an entry point into the cosmetology field and enable students to access jobs faster; only 600 course hours are required to take the esthetics exam, as opposed to the 1,000 hours required to take the cosmetology exam. Additionally, with recent funding formulas becoming effective in the near future, the number of certificates offered through a new esthetics program would foster supplementary funding for our institution.

**List any related recommendations.****Overview of Recommendations**

In Spring 2023 the Academic Senate approved moving forward with developing curriculum for a Cosmetology Teacher Training Program. Hiring a coordinator, a teacher aid, a bonded cashier, and a fourth full-time cosmetology instructor will foster consistency in our program. In turn, our program will be better prepared to incorporate a Cosmetology Teacher Training Program into our existing program.

**Changes within the Academic Field Industry**

The state of California has reduced required cosmetology clock-hours for licensure from 1,600 to 1,000. This substantial change caused cosmetology courses and program revisions in Curriqnet. As a result, new 1,000 hour student time cards needed to be designed that align with the new curriculum and available to view below. The reduction in hours may cause our advanced clinic floor to have fewer students enrolled because, based on attendance, they may not need COSM - 114 and COSM - 116 to complete their clock-hours.

**Direction and Vision**

The direction and vision for our program is structured around an organizational culture of growth that supports student learning in diverse areas of the beauty industry.

**Esthetics Program**

Depending on the new infrastructure, esthetics curriculum may be re-activated and implemented to create a new esthetics program. The contemporary program will allow students to earn



an esthetics license upon completing 600 course hours. This exciting development will allow each student to earn a certificate and gain entry into the growing skin care trade. Because the program is completed in less time than the cosmetology license, students may enter the workforce at a faster pace and begin earning current industry wages.

### **Cosmetology Teacher Training Program**

A second program that may be considered is a teacher training program that requires 600 clock-hours. The Academic Senate approved moving forward with designing the curriculum in Spring 2023.

### **Crossover Barber Program**

Thirdly, a crossover barber program may be considered that will allow current cosmetology license holders to earn the 200 clock-hours necessary to take the barber's exam through the State Board of Barbering and Cosmetology. The potential barber program, like the esthetics program, may also provide a certificate to each graduating student. At this time, the Academic Senate has not approved moving forward with designing a barber curriculum.

### **Overview**

Although these three programs offer enrollment pipelines that potentially increase student numbers on campus and foster academic funding in correlation with the new funding formula, the primarily goal is to foster student success in career technology training so students may earn a livable wage. Seeing these new programs come to fruition will require the support of requested recommendations identified throughout program review sections being achieved.

#### **Related Recommendations and Overview**

Related recommendations are intertwined with staffing recommendations, infrastructure developments, and new program curriculum design. In order to best implement new programs, the staffing recommendations of a coordinator, esthetics instructor, bonded cashier, fourth full-time cosmetology instructor, and a teacher aid is essential to effective departmental consistency. To ensure the completed design is conducive to future program growth opportunities, all full-time cosmetology instructors should be consistently involved throughout infrastructure developments.

9. It is common among CCC Cosmetology Programs to have a coordinator. Provided the growth and size of our program, which includes the CC day and evening program and the PAS day off-site location, we require a coordinator to maintain consistency within our program. A coordinator contributes to the department running smoothly and their duties may include, yet not limited to, ordering kits, ordering books, scheduling field trips, and acting as a liaison between our department and other campus departments. Filling a coordinator position would cost approximately \$45,000.

10. Additionally, having a full-time cosmetology aide to share between rooms TV-1 and TV-4 would benefit the quality of one on one instruction provided to all students at a cost of approximately \$45,000.
11. We have had the wonderful opportunity to employ CC students through Cal/WORKS to run our front desk. Although they have been an asset to our department, it would benefit the program to add an additional permanent bonded cashier position for our growing clinic floor. When we do not have Cal/WORKS student to run the front desk, enrolled students run the front desk. Due to the high volume of cash we collect, it would be best if the cashier position was held by an official licensed and bonded part-time classified staff member at an annual cost of approximately \$22,000.
12. As our department grows, and new infrastructure is completed, we remain open to offering an esthetics program. The programs would require an additional full-time esthetics instructor, at an annual cost ranging from \$59,588.00 to \$89,569.00. The esthetics program would serve as an entry point into the cosmetology field and enable students to access jobs faster; only 600 course hours are required to take the esthetics exam, as opposed to the 1,000 hours required to take the cosmetology exam. Additionally, with recent funding formulas becoming effective in the near future, the number of certificates offered through a new esthetics program would foster supplementary funding for our institution.
